INAUGURATION OF PERMANENT LOK ADALAT (PUBLIC UTILITY SERVICES) AT FARIDABAD ON 3.12.2011



Inauguration of Permanent Lok Adalat (PUS) by Hon'ble Mr. Justice S.K.Mittal, Judge, Punjab & Haryana High Court and Executive Chairman, HALSA

Hon'ble Mr. Justice S.K.Mittal, Judge, Punjab and Haryana High Court, & Executive Chairman, HALSA, Chandigarh inaugurated Permanent Lok Adalat (Public Utility Services) in the District Courts Complex, Faridabad in the presence of Sh. Darshan Singh, District and Sessions Judge, Deepak Gupta, Member Secretary, Haryana State Legal Services

Authority, Chandigarh, Sh. Rakesh Gupta, Deputy Commissioner, Faridabad, Shri S.S.Kapur, Commissioner of Police, Faridabad, Judicial Officers and Officers of District Administration, Faridabad on 3.12.2011 at 10.00 A.M. Sh. R.K.Kashyap, Additional District and Sessions Judge (Retired) assumed charge of Chairman and Smt. Upasana Bagla & Sh. Tarun Kumar Gupta joined as members of Permanent Lok Adalat (Public Utility Services), Faridabad and started functioning.

The core objective of this Permanent Lok Adalat is to ensure expeditious and effective remedy at pre-litigation stage to the people regarding disputes relating to Public Utility Services, which would include issues relating to Transportation, Telecom, Postal, Telegraph, Public Cleanliness, Hospitals, Banking, Finance, Insurance, Electricity, Water Supply, Housing and Estate Department from both Public and Private sectors. The most striking feature of this Adalat is that it doesn't involve cumbersome procedure. Rather, an aggrieved person would just have to write his problem on a piece of paper and submit it before the presiding officer. Besides that, parties would have the opportunity to settle their matter amicably by conciliation process.

Addressing the media, Hon'ble Mr. Justice S.K. Mittal disclosed that the disputes related to above mentioned issues would be settled on the basis of its merits and weakness and that pecuniary limit of PLA(PUS) would be upto Rs.25 lacs. Not

only that, the order passed by Lok Adalat would be executable like a decree passed by the Civil Court, and no appeal would lie against the orders, as it will attain finality immediately with its pronouncement. The aggrieved person will be at liberty to either present his case through lawyer or even personally and this can be initiated only at pre-litigative stage.

The Adalat started functioning on the very first day of its inception and heard 31 cases related to Banking problems. At the time of its inauguration, the Panel Advocate Ravinder Gupta expressed his gratitude that now people will not have to run from pillar to post for the redressal of their problems to different departments. He stated that this Adalat would also be helpful as a tool to check the arbitrariness of quasi, private and private sectors.

At the end, His Lordship motivated the Members of the Bar, Para Legal Volunteers and Mediators with his invaluable words and told that the success of the Adalat would depend upon their patient hard work.

It was suggested by the panel advocates that a quarterly meeting of panel advocates may be convened to discuss day to day problems faced by them. His Lordship assured that such meetings shall be held at Divisional level.

ACID ATTACK ON GIRL AT ROHTAK

The Member Secretary, NALSA forwarded a complaint (through fax) made by one Manoj Kumar R/o Rohtak, alleging police inaction in a case relating to acid attack on 3 girls on 18th June, 2011, regarding which FIR No.281, 282 & 283 all dated 18.6.2011 had been registered at P.S. Sector 4, Urban Estate, Rohtak. It was alleged that despite the victim having identified the culprits, no action was being taken by the police. It was stated in the letter by Member Secretary, NALSA that since matter involved a heinous crime occurred to a young girl, it was the responsibility of NALSA, especially during the year 2011-2012 which is being observed as "Year of the Rights of the Child", to see that the child's rights are protected and justice is meted out to her.

Status report in respect of the matter under reference was called from District & Sessions Judge-cum-Chairman, District Legal Services Authority, Rohtak.

The matter was brought to the notice of Hon'ble Mr. Justice S.K.Mittal, Judge, Punjab & Haryana High Court-cum-Executive Chairman, HALSA. After going through the report of Chairman, DLSA, Rohtak and as per the directions of His Lordship, HALSA

decided to file a writ petition in the Hon'ble High Court, for proper investigation of the case by some independent agency so that investigation is carried out by some senior, impartial & honest officer and for other appropriate directions. The matter has been entrusted to Sh. P.S. Ahluwalia, Advocate for necessary action in the Hon'ble High Court.

सुलह से स्थाई लोक अदालत में निपटेंगे मुकदमे

फरीदाबाद | कठिण संवाददाता

जन उपयोगी सेवाओं से जुड़े मामलों का निपटान करने के लिए जिले में स्थाई लोक अदालत कागिनार को खुल गई, इससे समूचे मामले बिना किसी मुल्क के बलाए जाये। दोनों पक्षों को बुराकर अदालत आपसी सुलह-समाहोत से मामले का निपटान करायागी। सेक्टर-12 अदालत परिसर में इसका उद्घाटन करने के बाद हरियाणा राज्य विधिक सेवा प्राधिकरण के चेयरमैन तथा हाईकोर्ट के जस्टिस प्रसन्न मिश्र ने पात्रकारों से बातचीत करते हुए यह जानकारी दी। उन्होंने बताया कि स्थाई लोक अदालत में 25 लाख रुपये तक के मूल्यांकन वाले मामलों को सुनवाई होगी। न्यायालय का आदेश विधिक न्यायकत्व को दिवानी के रूप में मान्य होता है और जिसको कोई अपील नहीं होती है। एक समाल के पत्राब में उन्होंने बताया कि यह अदालत उन लोगों के लिए काफी फायदेमंद होगी, जो पैसे के अभाव में न्याय के लिए अदालत का दरवाजा नहीं खटखटा पाते हैं। उन्होंने बताया कि प्राधिकरण के तर्फ से उनको वकील की सेवाएं मुफ्त मिलेंगी। प्राधिकरण के पैन्ल में ऐसे काफी वकील हैं। चेयरमैन ने बताया कि लोगों को उनके अधिकारों के प्रति जागरूक करने के लिए जिले में भारतीय कानूनी सहायता कर्त्तविक खोले जाने की योजना है। इस लोक अदालत में परिचहन, ट्रेडिंग, पोस्टल, टेलीग्राफ, जन स्वच्छता, चिकित्सालय, वैकिंग एवं विवा, इन्शोरेंस, विद्युत, जल आपूर्ति सेवा, आवासर एवं संपन्न से जुड़ी जन उपयोगी सेवाओं के मामले दायर किए जा सकते हैं।
