HARYANA STATE LEGAL SERVICES AUTHORITY RELEASED A BOOKLET ON VICTIM COMPENSATION LAW



Hon'ble Mr. Justice Ajay Kumar Mittal, Executive Chairman of Haryana State Legal Services Authority, released a booklet on "Victim Compensation Law", prepared by Haryana State Legal Services Authority. It was released in the workshop conducted for all the Chief Judicial Magistrates-cum-Secretaries of District Legal Services Authorities of Haryana at HALSA office, Sector 14, Panchkula.

Haryana Victim Compensation Scheme, 2013 is being implemented in the State of Haryana by Haryana State Legal Services Authority. Since 2013, compensation of an amount of more than Rs 5 Crore has been disbursed to the victims of crime who require rehabilitation. Under this scheme, victims of certain crimes as per schedule 1 of the scheme are entitled to compensation. It includes the victims of acid attack, rape, loss of limb,

molestation etc.

Justice Ajay Kumar Mittal emphasized the need to work for the weaker and marginalized sections of society, and to increase the quality of legal services rendered to marginalized sections of society. Justice Ajay Kumar Mittal stressed that work in Legal Services Authorities must be done with honesty, sincerity and devotion. Officers were sensitized on Victim Compensation Law and the various aspects of access to justice and legal aid programmes. Various legal aid schemes which are being implemented by Haryana State Legal Services Authority were also discussed. The ways and means to implement Mediation and Lok Adalats in an effective and meaningful manner for resolving disputes were also discussed.



SPECIAL LEGAL LITERACY CAMP DURING NAVRATRA MELA



A Special Legal Literacy Camp was organized during Navratras at Mata Mansa Devi Temple Complex, Panchkula from 8.4.2016 to 15.4.2016. The legal literacy camp at Mata Mansa Devi Temple evoked enthusiastic response from the visitors

who visited the camp in large numbers. Panel lawyers and Para Legal Volunteers rendered their services at the camp. Books and pamphlets, prepared by Haryana State Legal Services Authority, were also distributed to spread legal awareness. Students of different schools also participated. Hon'ble Mr. Justice Ajay Kumar Mittal, Judge, Punjab and Haryana High Court-cum-Executive Chairman, Haryana State Legal Services Authority, also visited the said stall. In the said camp, flex banners, reflecting the fundamental duties, as contained in the

Constitution of India, and provisions of various laws such as The Maintenance of Parents and Senior Citizens Act, 2007, Prohibition of Child Marriage Act, 2006 etc. were displayed to educate the public.



AWARENESS CAMPS ON WORLD NO TOBACCO DAY

Smoking tobacco is a global health threat. World No Tobacco Day is observed every year on May 31. On 31/5/2016, District Legal Services Authorities across the State of Haryana held awareness camps under the aegis of Haryana State Legal Services Authority to draw attention to the health problems that tobacco use can cause. It was emphasized in the camps that it is not just the

smokers who are at risk. The people around them, the so called passive smokers, are also vulnerable to developing smoking related diseases. Tobacco, no matter in which form it is, like cigarettes (even light or filtered), cigars, chewable tobacco, huqqa or even the ever popular sheesha, is a silent killer. On 14.5.2016, monthly National Lok Adalat on the MACT and Insurance Matters (PLA/PUS) was held. In the said Lok Adalat, 173 cases were settled. Pre-litigation cases as well as pending cases were settled involving an amount of Rs.3,67,72,031/-.

To make the monthly National Lok Adalats successful, meetings were held by

Session Judges with the Judicial Officers to identify the matters which could be settled in the Lok Adalat.

For the purpose of effective disposal of MACT cases, directions were issued to all the District Legal Services Authorities that the MACT Benches must include Orthopedic and other doctors as members for National Lok Adalat. Special Benches were also directed to be constituted for speedy disposal of the cases.






VISIT TO DISTRICT LEGAL SERVICES AUTHORITIES

The Act provides for both the preventive and promotional aspects of rehabilitation like education, employment and vocational training, reservation, research and manpower development, creation of barrier-free environment, rehabilitation of persons with disability, unemployment allowance for the disabled, special insurance scheme for the disabled employees and establishment of homes for persons with severe disability etc.

"JAN SAMPARK ABHIYAN" IN PANIPAT BY DLSA



District Legal Services Authority, Panipat launched "Jan Sampark Abhiyaan" to spread awareness among the public about the existence of District Legal Services Authority and the various legal aid programmes being carried out by it. In the said context, march was carried out on 26.5.2016.



The march started from ADR Centre. Chief Judicial Magistrate-cum-Secretary, DLSA, Panipat along with Panel Advocates and Para Legal Volunteers walked through the city of Panipat (about four kilometers) for direct interaction with people. Two big banners, printed in English and Hindi, carried the message about District Legal Services Authority. The helpline number was also displayed. Four thousand pamphlets spelling out the eligibility conditions for obtaining legal aid were distributed amongst the general public at places like Bus Stand, Cycle Rikshaw stands, Auto Rikshaw Stands and other busy business centers like Insar Market etc.



LEGAL AWARENESS CAMPS IN THE RURAL AREAS OF PANIPAT



On 17.5.2016, District Legal Services Authority, Panipat, organized four awareness camps in the schools of villages Nara, Dariyapur, Urlana Kalan and Urlana Khurd. Each camp served three purposes. Firstly, the people were made aware about their rights and duties and the schemes floated by NALSA. The provisions of victim compensation scheme were discussed and information relating to Accident Information Report in motor accident claims was given. The pamphlets of "Motor Accident Claims relating to Accident Information Report" were distributed among the general public in pursuant to the directions issued by Haryana State Legal Services Authority. Similarly, pamphlets of Permanent Lok Adalat (Public Utility Services) were also distributed. Secondly, the students were told about the Fundamental Duties as envisaged in the Constitution of India. Thirdly, an effort was made to implement the NALSA (Victims of Trafficking and Commercial Sexual Exploitation) Scheme - 2015, as far as "Prevention" of any such illegal act is concerned. The school children were advised about the dangers of strangers befriending them. They were further urged to boldly discourage child marriage and in case any such incident happens with them, they may report the matter to the police, DLSA or DCPO (District Child Protection Officer). The teachers were also asked to convey this message to the

parents of the school children during parentteacher meetings about the falsity of promises made to them by outsiders in the name of better education of their children in big cities. The teachers were further advised to keep a close watch on children not attending school for a couple of days. All of them were asked to take the aid of students' literacy clubs to discuss these issues regularly.



AWARENESS PROGRAMME IN DISTRICT JAIL KARNAL

On 04.05.2016, District Legal Services Authority, Panipat held awareness camp for jail inmates after the conclusion of jail lok adalat on the said day. Chief Judicial Magistrate cum Secretary, DLSA, Panipat addressed the undertrials and informed them about free legal aid and the purpose of legal care and support centre in jail premises. They were also apprised about the various activities being carried out by District Legal Services Authorities. The grievances of the undertrials were heard through personal interaction.



WORKSHOP ON VICTIM-SENSITIVE APPROACH

On 21.05.2016, workshop was organized by District Legal Services Authority, Kurukshetra for sensitizing the Panel Lawyers and the Para Legal Volunteers to have sensitive approach when dealing with the cases of women and child victims. It was

Under this Scheme, lady advocates visit police stations as per the schedule, and provide legal assistance to the victims of rape and other crime against women and children.

emphasized that women and children often face difficulties regarding Access to Justice, and the need is to provide quality legal services to the said section of society by taking extra care to deal more sensitively with them. Sh. Narender Pruthi, Physiatrist, LNJP Hospital also addressed the Panel Advocates and Para Legal Volunteers.

WORKSHOP ON SECTION 158 (6) OF MOTOR VEHICLES ACT

On 17.05.2016, workshop was organized in the conference hall of ADR Centre Kurukshetra to sensitize the Judicial Officers. Police Officers and the Panel Advocates and Para Legal Volunteers about the different aspects of Section 158(6) Motor Vehicles Act, 1988. It was presided over by Sh. Arun Kumar Tyagi, District & Sessions Judge-cum-Chairman, District Legal Services Authority, Kurukshetra. It was emphasized in the said workshop that Section 158 (6), mandates SHOs to submit an accident information report to the Motor Vehicle Accident Claims Tribunal within 30 days of the accident. The Claims Tribunal shall treat the said report as a claim petition and conduct an enquiry into the same. Important directions given by the Hon'ble Supreme Court in Jai Parkash Vs. National To ensure that all accident victims get compensation, it is necessary to formulate a more comprehensive scheme for payment of compensation to victims of road accidents, in place of the present system of third party insurance.

PROGRAMME FOR DDPO AND BDPOS

On 16.05.2016, a programme was organized by District Legal Services Authority, Kurukshetra for District Development and Panchayat Officer (DDPO), Block Development, Panchayat Officers (BDPOs) and Sarpanches of the villages. It was organized with an aim to sensitize them about the functioning of Legal Care and Support Centres opened in various villages in District Kurukshetra. They were exhorted to spread awareness about the utility of Legal Care and Support Centres amongst the villagers so that weaker and marginalized sections of society utilize the services rendered at those centres. It was emphasized that Sarpanches should take due care while issuing attendance certificates to Panel Advocates and Para Legal Volunteers for attending Legal Care and Support Centres.



SENSITIZING PRINCIPALS ABOUT LEGAL LITERACY CLUBS

Under the Students Legal Literacy Mission, the principals of Government and Private Colleges were sensitized by Chief Judicial Magistrate-cum-Secretary, District Legal Services Authority, Mewat about the Legal Literacy Clubs. The principals of colleges where Legal Literacy Clubs have not been opened were impressed upon to open Legal Literacy Clubs in the colleges so that the objective of making students aware of the various rights and duties under various laws is achieved.



LEGAL AWARENESS IN SCHOOLS

On 11.05.2016, lectures on Fundamental Duties were given by Chief



Judicial Magistrate cum Secretary, DLSA Jhajjar to the students of Govt.Sr. Secondary School at village Guddha and Govt. Sr. Secondary School at village Dujana. OBSERVANCE OF ANTI-TERRORISM DAY






On 21.05.2016, District Legal Services Authority, Mewat in coordination with Care Trust, Mewat and Muslim Maha Sabha

LEGAL SERVICES TO THE WORKERS IN THE UNORGANIZED SECTOR

On 21.05.2016, Panel Lawyers were sensitized by DLSA, Kurukshetra about the newly launched scheme of NALSA regarding workers in the unorganized sector. The panel lawyers were explained the existing legal frame work regarding the workers in the unorganized sector. They were also told about NALSA (Legal Services to the Workers in the Unorganized Sector) Scheme, 2015.

OBJECTIVES OF THE NALSA SCHEME

- 1. To institutionalize essential legal services to all unorganized workers.
- 2. To get the gaps in legislation/implementation plugged through coordination with government authorities and by initiating public interest litigation.
- To mobilize the machinery of the State Government and the District Administration to identity and register all unorganized workers in all categories and to extend the benefits of all governments schemes, as applicable to them.
- To spread awareness among the employees regarding the statutory provisions and the need for providing decent working conditions, living wages and social security to the workers.
- To disseminate information among the workers regarding their entitlements under the existing legislations and schemes.
- To provide counseling and assistance to all categories of unorganized workers for their registration with the concerned authorities under the schemes available for their category.
- To assist the workers in availing the benefits of the scheme for which they are registered as per their need/entitlements.



AWARENESS ON EARTH DAY

On 22.04.2016, District Legal Services Authority, Mewat at Nuh held an awareness camp in coordination with Care Trust on the occasion of Earth Day. It was organized with an objective to make people understand the importance of environmental issues so that more people become aware of the actions which are required to be taken to protect our environment. The importance of planting trees was also emphasized.



CHILDREN HOMES, SHELTER HOMES, OBSERVATION HOMES

Children and senior citizens are vulnerable. Children are voiceless and defenseless. Nurturing children in an environment free from exploitation and fear is very important. Children in Children Homes, Shelter Homes and Observation Homes form the most vulnerable section. Similarly, Senior Citizens, living in the Old Age Homes, also form the vulnerable section who apart from legal protection also require the motivation to live happily and fearlessly. To ensure proper legal protection to this vulnerable section, the Chairmen cum District and Sessions Judges alongwith Chief Judicial Magistrates cum Secretaries have been making visits regularly every month to Children Homes, Shelter Homes, Observation Homes and Old age homes across the State of Haryana under the instructions and guidance of the Haryana Legal Services Authority. Deficiencies are taken up with the concerned authorities. Legal aid is also provided in appropriate cases.

AWARENESS CAMP AT VILLAGES

AWARENESS ON POCSO ACT



District Legal Services Authority, Panchkula organized Legal Awareness Programmes in the various schools at Panchkula in the month of May, 2016 to spread awareness about POCSO Act. The students were told that the Protection of Children from

Sexual Offences Act (POCSO Act), 2012 was formulated in order to effectively address sexual exploitation of children. They were told that the Act defines a child as any person below 18 years of age. It provides for special courts. Trials are conducted without revealing the identity of the child. The copies of booklet on "Protection of Children from Sexual Offences Act (POCSO Act), 2012" prepared by Haryana State Legal Services Authority were also distributed amongst the students.

CHILD FRIENDLY PROCEDURES AS INCORPORATED IN POCSO ACT

- * Recording the statement of the child at the residence of the child or at the place of his choice, preferably by a woman police officer not below the rank of sub-inspector. Evidence has to be recorded within 30 days.
- * No child to be detained in the police station in the night for any reason.

- * Police officer not to be in uniform while recording the statement of the child.
- * The statement of the child to be recorded as spoken by the
- * Assistance of an interpreter or translator or an expert as per the need of the child.
- * Child not to see accused at the time of testifying. The evidence of the child shall be recorded within a period of 30 days of the cognizance of the offence.
- * Assistance of special educator or any person familiar with the manner of communication of the child in case child is disabled.
- * Medical examination of the child to be conducted in the presence of the parent of the child or any other person in whom the child has trust or confidence.
- * In case the victim is a girl child, the medical examination shall be conducted by a female doctor.
- * Child not to be called repeatedly to testify and frequent breaks to be given to the child during the trial.
- * No aggressive questioning or character assassination of the child.
- * Trial to be in the special court in camera.

STUDENTS LEGAL LITERACY MISSION

In the year 2005, National Legal Literacy Mission was launched. Its motto is "From Ignorance to Legal Empowerment". The primary objective of the mission is to lift the veil of ignorance through knowledge and to spread awareness amongst people about their rights. The masses should be aware of the law of the land. It is all the more important that the youth are educated about the laws so that they grow up to be law abiding citizens. Students can prove to be an extremely valuable asset in the dissemination of information with regard to the laws. Hence, under this mission, Haryana State Legal Services Authority (HALSA) has adopted the project of Students Legal Literacy Mission (SLLM) along with various other projects.

Under this project, Haryana State Legal Services Authority (HALSA) in collaboration with Haryana Education Department has opened Legal Literacy Clubs (LLC) in schools and colleges in the State of Haryana.

This project aims to create a generation for future which is well aware of its constitutional & statutory rights and duties. It also aims to make them aware about issues of socio-legal



relevance so as to help in promoting rule of law and social justice in the country.

Under the students literacy mission, the following types of competitions are held:-

- * Declamation contest
- Poetry recitation
- ^{*} Debate
- * Essay writing
- * On the spot painting

- * Slogan writing
- * Power Point Presentation
- * Preparation of Documentary Films on socio-legal issues.

On 29.4.2016, state level competitions at school level were held at Kurukshetra. On 23.4.2016 divisional level competitions at college level were held at Gurgaon.



SOME RECENT JUDGMENTS OF THE SUPREME COURT OF INDIA

RIGHT TO FREE SPEECH CANNOT MEAN THAT A CITIZEN CAN DEFAME THE OTHER

In Subramanian Swamy versus Union of India, Ministry of law & ors (Writ Petition (criminal) no. 184 of 2014) decided on May 13, 2016 the Hon'ble Supreme court, inter-alia, observed and held as follows:

The right to freedom of speech and expression is a highly valued and cherished right but the Constitution conceives of reasonable restriction.

Criminal defamation which is in existence in the form of Sections 499 and 500 IPC is not a restriction on free speech that can be

characterized as disproportionate. Right to free speech cannot mean that a citizen can defame the other. Protection of reputation is a fundamental right. It is also a human right. Cumulatively it serves the social interest.

CHILDREN REQUIRE ADEQUATE NUTRITION

In Swaraj Abhiyan (II) Versus Union of India & Ors (Writ Petition (C) No. 857 Of 2015) decided on May 13, 2016 the Hon'ble Supreme court, inter-alia, observed and held as follows:

No one can doubt that children are the future of our country and if there is some stinginess in providing them with adequate nutrition, the country as a whole is deprived in future of taking the benefit of their potential.

The States of Bihar, Haryana and Uttar Pradesh must within a month from today make adequate provision for the supply of eggs or milk or any other nutritional substitute for children under the Mid-Day Meal Scheme. Eggs, milk or another nutritional substitute should be made available preferably five days in a week or at least three days in a week.

Although Article 47 is not enforceable being a Directive Principle, there is considerable moral force and authority in this provision to persuade the State Governments and the Government of India to attempt at ensuring that the people, particularly those in drought affected areas, are provided adequate food grains and a cooking medium for the preparation of their meals.

In the States in which drought has been declared or might be declared in the future, all households should be provided with their monthly entitlement of food grains in terms of the NFS Act regardless of whether they fall in the category of priority household or not. The provision made under the NFS Act shall be in addition to and not in derogation of any other entitlement under any other government scheme.


