STUDENTS LEGAL LITERACY MISSION-ANNUAL FUNCTION-2014



Under the National Legal Literacy Mission, Haryana State Legal Services Authority (HALSA) with the cooperation of Education Department, Haryana launched Student Legal Literacy Mission in the State of Haryana in the year 2009. This mission is a significant step towards implementation of the policy 'Access to Justice for all'. The mission has

been established so that the students can understand law; and is aimed at educating specified target groups, who are marginalized and vulnerable sections of our society through awareness and free legal aid. The main aim of this programme is to educate students about their constitutional and statutory rights & duties, of which they are unaware.

Under the Mission, HALSA with the cooperation of Education Department,

opened Legal Literacy Clubs in more than 2600 Government Senior Secondary/Secondary Schools and 192 in Govt. Colleges and 1045 private schools/colleges. In these clubs, students are informed of the legal rights and duties of citizens and about the issues of socio-legal relevance, including female foeticide, environment, juvenile justice, legal remedies, social justice legislations, constitutional values, national security and sovereignty.



To give impetus to the project, competitions are organized in essay writing, declamations, poetry recitation, skits, slogans and paintings at school/college level, District level, Divisional level and finally at State Level. The winners of Divisional level competitions are given prizes of Rs.5,000/-, 4,000/- and 3,000/- for the first, second and third prize respectively in each category; whereas winners at the State Level are awarded prizes of Rs.11,000/-,8,000/- and 5000/- for the first, second and third prizes respectively. Besides this, Gold, Silver and Bronze medals are also given to the winner students.

HALSA in collaboration with Education Department, Haryana organize such competitions. For the first time, such competitions were held in the year 2009 followed by the annual function at Kurukshetra on 6.2.2010. About 12000 students participated in the competitions. In the second year, about 17000 school



students participated in the competitions followed by the Second Annual Function at Kurukshetra University Auditorium on 19.2.2011. In the third year, approximately 26,500 students participated in the competitions at various levels, and Annual Function was organized at Rohtak on 20.5.2012. In the fourth year, Approximately 45400 students participated in the competitions at the

various levels and the State level function of "Student Literacy Mission-Annual Completion" was held on 19.05.2013 at Brahmakumari's Om Shanti Retreat Centre, Village Bhora Kalan, District Gurgaon. Approximately 3500 students attended the State Level Function.

Previously competitions were organised on 10 topics, but during the year 2013-14, competitions were organised on 17 topics in the Colleges and Schools, which are as follows:-



SOME RECENT JUDGMENTS OF THE SUPREME COURT OF INDIA

A NATION WITH A DESIRE TO PROSPER IS REQUIRED TO MAINTAIN HIGH DEGREE OF LAW AND ORDER SITUATION

The Hon'ble Supreme Court in the judgement given in Chandra Prakash Versus State of Rajasthan (CRIMINAL APPEAL NO.1155 OF 2014 decided on May 9, 2014), inter-alia, observed as follows:

Every citizen of this country is required to remember that national patriotism is founded on the philosophy of public good. Love for one's country and humanity at large are eternally cherished values.

A nation with a desire to prosper is required to maintain high degree of law and order situation apart from respecting "imperatives of internationalism".

26th January is the date in 1950, when our organic, inclusive, humane and compassionate Constitution came into existence being given by the people of this country to themselves and the nation has been obliged to jubilate remembering the said important day in our national history, for it chartered the path of many an emancipation and conferred on the people the highly cherished fundamental rights.

COURT TIME LOST IS A DIRECT LOSS TO THE NATION

The Hon'ble Supreme Court of India in the judgement given in Subrata Roy Sahara versus Union of India and others (WRIT PETITION (CRIMINAL) NO. 57 OF 2014 decided on May 6, 2014), inter-alia, observed as follows:

The judiciary as an institution, has extremely sacrosanct duties, obligations and responsibilities.

The Indian judicial system is grossly afflicted, with frivolous litigation. Ways and means need to be evolved, to deter litigants from their compulsive obsession, towards senseless and ill-considered claims. One needs to keep in mind that in the process of litigation, there is an innocent sufferer on the other side, of every irresponsible and senseless claim. He suffers long drawn anxious periods of nervousness and restlessness, whilst the litigation is pending, without any fault on his part.

Court time lost is a direct loss to the nation.
