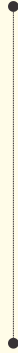

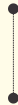

8th ANNUAL FUNCTION 'STUDENTS LEGAL LITERACY MISSION'



1. Background

In the year 2005, National Legal Literacy Mission was launched. Its motto is "From Ignorance to Legal Empowerment". The primary objective of the mission is to lift the veil of ignorance through knowledge and spread awareness amongst people about their rights. The masses should be aware of the laws of the land. It is all the more important that the youth are educated about the laws so that they grow up to be law abiding citizens. Under this mission, Haryana State Legal Services Authority (HALSA) has adopted the project of Students Legal Literacy Mission (SLLM) along with

various other projects.

Under this project, Haryana State Legal Services Authority (HALSA) in collaboration with Education Department of Haryana Government has opened Legal Literacy Clubs (LLC) in schools and colleges in the State of Haryana.

This project aims to create a generation for future which is well aware of its constitutional & statutory rights and duties. It also aims to make them aware about issues of socio-legal relevance so as to help in promoting rule of law and social justice in the country.

2. Constitution of Legal Literacy Clubs:

In the first phase, Legal Literacy clubs in 1544 Government Senior Secondary Schools and 171 in Government and Government aided Colleges were opened by Haryana State Legal Services Authority in collaboration with Department of Education, Haryana, covering about one third students community.

In the second phase, HALSA is taking steps to open such Legal Literacy Clubs in all the private Senior Secondary Schools/ Secondary Schools/Colleges and other educational institutions of Haryana so as to cover remaining 2/3rd students community.

The Students Legal Literacy Clubs run under the guidance of the "Teacher-in-Charge" and under the overall supervision of the Headmaster/Principal of the respective High School/College. At present 6618 legal literacy clubs are functional in various schools & colleges in the state of Haryana.

The programme started with the auspicious lighting of the lamp by the dignitaries with Saraswati Vandana in the background.

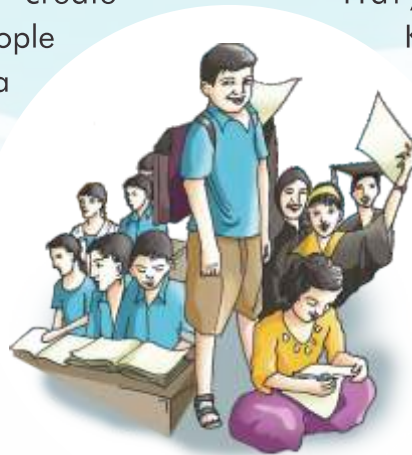
During the function Hon'ble Mr. Justice Ajay Kumar Mittal, Judge, High Court of Punjab and Haryana, Executive Chairman, Haryana State Legal Services Authority conveyed that legal literacy is the basic core of the rule of law and is essential in its understanding for the survival of constitutional democracy. Lack of legal awareness in society is mainly responsible for exploitation and unlawful deprivation of basic rights and social benefits. Many problems like child labour, human trafficking, child abduction, domestic violence and child marriage etc. are



prevalent in the society. To create awareness and to sensitize the people about these problems, Haryana State Legal Services Authority took this initiative to spread/support Students Legal Literacy Programme. By taking clue from Haryana, National Legal Services Authority (NALSA) has requested the other State Legal Services Authorities across the nation to start Legal Literacy Clubs in the educational institutions in their respective States.

Justice A. K. Mittal also announced that in order to increase the level of Legal Literacy and create awareness among students at School Level, 5 Legal Literacy Clubs in schools of each District will be shortlisted and provided with Computer, Furniture Items and Literature on Legal Literacy, as per NALSA guidelines, so that a dedicated space along with healthy environment is available to Students for inculcating the knowledge about their rights and they could patronize the marginalized section among their neighbourhood.

Hon'ble Mr. Justice Gurmeet Singh Sandhawalia, Judge, High Court of Punjab &



Haryana, Administrative Judge, Kurukshetra Sessions Division acknowledged the efforts of Haryana State Legal Services Authority to make Students Legal Literacy Mission a success.

Ms. Jyoti Arora, IAS, Principal Secretary to Government of Haryana, Department of Higher Education and Ms. Dheera Khandelwal, IAS, Additional Chief Secretary, Department of School Education congratulated the winners. They also appreciated the work and labour put in by the students and all others who participated in this event.

The dignitaries during their visit to the exhibition noticed the paintings and slogans made by students of Schools and Colleges on various socio-legal topics. The school students also made rangoli, which was also acknowledged by the dignitaries.

GLIMPSES OF ANNUAL FUNCTION















32nd Surajkund International Crafts Mela was organized from 2nd to 18th February in Faridabad. Mela celebrates the unique diversity of Indian traditions and culture in an ambience created to represent the ethos of rural India.

Haryana State Legal Services Authority (HALSA) displayed a stall from 2nd to 18th February, 2018 in the said Mela with an aim to create legal awareness amongst the masses and to ensure the access to justice for all. The stall was inaugurated by Hon'ble



Mr. Justice Ajay Kumar Mittal, Judge, High Court of Punjab and Haryana-cum-Executive Chairman, Haryana State Legal Services Authority on 2nd February, 2018. Disadvantaged groups remain largely invisible to the formal legal system and therefore, continue to suffer the substantive inequalities. To make these people aware about the abovesaid socio-legal problems, HALSA stall was decorated with Banners, Posters, Hoardings, Flexes and Standees exhibiting the aims, objectives, schemes and

achievements of HALSA.

The members of Legal Fraternity of the State including District and Sessions Judges of various Districts, other Judicial Officers and the officers of District Administration also visited the Stall. The dignitaries who visited the stall appreciated the artistic performances of school and college students on legal issues.

The attention of public was also drawn towards the benefits of resolution of disputes through Lok Adalat and the benefits thereof. Every day, hundreds of people visited the Stall and watched the events organized by HALSA. Attempt was made to sensitize them on the issues of social and legal importance including child labour, rights of transgenders, Fundamental Duties, Right to Education and Drug Abuse etc.

In addition to this, HALSA also created awareness in masses by launching a software namely "Legal Awareness Initiative-Let's bring a change". It had served twofold purpose. Firstly, a





survey was carried out upon 15 prominent socio-legal issues. Secondly, where ever the information provided by General public required a quick action upon the menace, the Panel Advocate drafted the complaint/application and the same was sent to the quarter concerned by a link from the website of National Legal Services Authority.

Apart from aforesaid peculiar formation, the stall was centre of attraction for various other reasons.

A LED of 8' x 12' (p5) size was also installed there. NALSA theme song, the slides pertaining the socio-legal issues upon senior citizens, child labor, women and female foeticide, documentaries of HALSA and NALSA and the clips of short





stories etc. were shown on it.

Chhoti Chaupal i.e a platform for cultural activities was also a part of stall. Total 16 activities were carried out by different schools and colleges of the District at 'Chaupal'. Sitting arrangement for 80 persons at a time were also made at the venue.

Apart from it, 19 items were performed at Badi Chaupal

(International platform for cultural activities carried out during the Surajkund International Crafts Mela) by the students of different School/Colleges. The programmes were performed by the students under Student Legal Literacy Mission Scheme and benefitted large number of viewers. In total 24376 visitors were registered at the stall of HALSA.

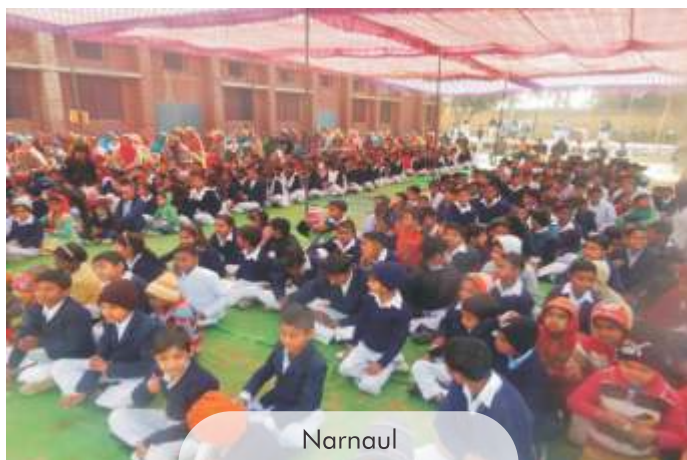

On 10.2.2018, National Lok Adalat on all the matters (Criminal compoundable, NI Act u/s 138, Bank Recovery Cases, MACT Cases, Matrimonial Disputes, Labour Dispute Cases, Land Acquisition Cases, Electricity Bills, Water Bills, Service Matters, Revenue Cases and Other Cases) was held. In the said Lok Adalat, 18635 cases including pending as well as at pre-litigative cases were settled. The amount settled was 23,39,25,293/-.

LEGAL SERVICES CAMP MODULE

Access to justice is essential for rule of law. Access to justice enables citizens to have their voices heard, exercise their rights and challenge discrimination. Access to justice is not confined to court based legal services. It extends to making people aware about their entitlements under various enactments, welfare schemes, programmes and strengthening their access to the same. Accordingly legal services camps are being organized by all District Legal Services Authorities in the state of Haryana under the aegis of Haryana State Legal Services Authority.

Further, a new model namely "LEGAL SERVICES CAMP MODULE" has been launched by National Legal Services Authority, wherein people are made aware about their entitlements and procedural aspects relating to the same. The objective is not only to make them aware about their entitlements and procedural aspects but also connect them to the welfare schemes meant for them. Thus the same is considered to be a "Delivery Based Model" for holding Legal Services Camps.

Accordingly, in the months from January, 2018 to March, 2018 the Legal Services Camps as per new MODULE were held at Barwala (Panchkula), Naneola (Ambala) and Shahabad (Kurukshetra) on 20.01.2018, 27.02.2018 and 09.03.2018 respectively.

PRE-CAMP Activities by District Legal Services Authority Panchkula, Ambala and Kurukshetra:

In order to make the camps a huge success and to identify the beneficiaries regular meetings were conducted with stakeholders/Government Departments. An attempt was made by District Legal Services Authority Panchkula, Ambala and Kurukshetra to apprise the Government Departments that Legal Services Authority is acting as a bridge between them and general public so as to ensure that the fruits of welfare schemes are passed to the eligible people.

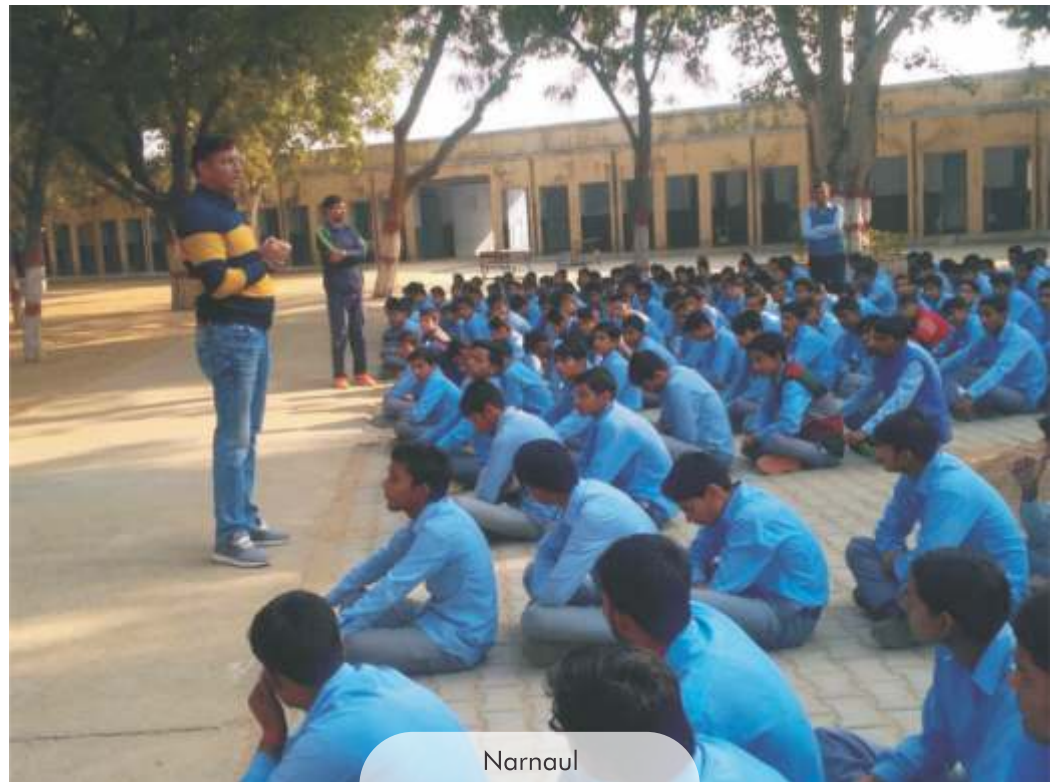

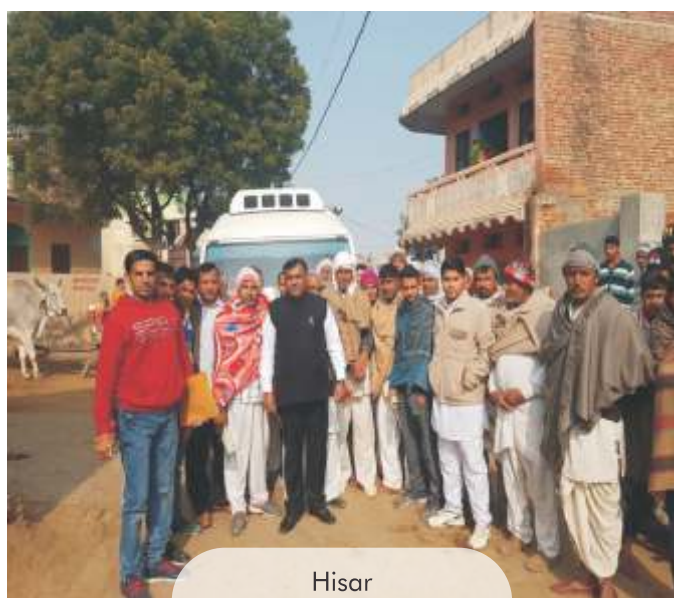
