"ONE LIFE" ROAD SAFETY AWARENESS CAMPAIGN

Everyone is a road user. Road crash fatalities are increasing day by day. As per the report titled "Road Accidents in India-2015", published by Ministry of Road Transports and Highways, the total number of road accidents increased by 2.5 per cent from 4,89,400 in 2014 to 5,01,423 in 2015. The total number of persons killed in road accidents increased by 4.6 per cent from 1,39,671 in 2014 to 1,46,133 in 2015. Road accident injuries have also increased by 1.4 per cent from 4,93,474 in 2014 to 5,00,279 in 2015. The severity of road accidents, measured in terms of number of persons killed per 100 accidents has increased from 28.5 in 2014 to 29.1 in 2015. The report further states that 1,374 accidents and 400 deaths take place every day on Indian roads.

Human life is precious. It has no substitute. Road safety is need of the hour. The main challenge of road safety is to bring about a change in road user behaviour. Road users should learn to consider the road as a shared public space. Human behaviour is a factor in over 90% of road crashes. In order to reverse the rising trend of road casualties awareness is required.

Awareness is required about the road signs, safe driving behaviour, law and the rules relating to proper and responsible vehicle use on road.

There is one more aspect. It is more often seen that people are hesitant to render immediate help to the road accident victims. The victims lay wounded on the road for sometime till the arrival of police. Delay in rendering medical help in such cases sometimes is fatal.

In Savelife Foundation & Anr. Vs. Union of India & Anr. (decided on 30.03.2016), the Hon'ble Supreme Court of India observed, inter-alia, as follows:



"Accident cases require fastest care and rescue which could be provided by those closest to the scene of the accident. Bystanders clear support is essential to enhance the chances of survival of victim in the 'Golden Hour' i.e. the first hour of the injury. As per the WHO India Recommendations, 50% of the victims die in the first 15 minutes due to serious cardiovascular or nervous system injuries and the rest can be saved through by providing basic life support during the 'Golden Hour'. Right to life is enshrined under Article 21 which includes right to safety of persons while traveling on the road and the immediate medical assistance as a necessary corollary is required to be provided and also adequate legal protection and prevention from harassment to good Samaritans."

Good Samaritans have the fear of legal consequences, involvement in litigation and repeated visits to police station. There is urgent need to spread awareness about the legal protection to Good Samaritans.

Road safety has many facets. Road safety is a shared responsibility. It requires the participation of all. The success of road safety strategies depends upon a broad base of support and common action from all stakeholders.

Keeping in view all these aspects, Haryana State Legal Services Authority launched "One Life": Road Safety Awareness Campaign, It was launched on 23.07.2016 in the Administrative Office of Haryana State Legal Services Authority at Panchkula by Hon'ble Mr. Justice Ajay Kumar Mittal, Judge, Punjab and Haryana High Court and Executive Chairman, Haryana State Legal Services Authority. On the launch of this programme, Hon'ble Mr. Justice Ajay Kumar Mittal said that "Road is being used by everyone of us in our day to day life. The increasing road fatalities these days are not only alarming but disturbing also. Many casualties take place annually which are outnumbering deaths due to diseases like Malaria, Tuberculosis etc."

Hon'ble Executive Chairman emphasized

the need to spread awareness and sensitize people about road safety. On the said occasion, Haryana State Legal Services Authority also released a handbook on Road Safety. Over 100 participants comprising of officers from District Administration, District Judiciary, Panchkula, Senior Police Officers, Panel Lawyers and Members of NGO's were present at the official launch of the campaign.

"One Life": Road Safety Awareness Campaign was held with the following aim:

- To raise public awareness about road safety issues.
- To raise awareness about road signs.
- To raise awareness about various provisions of Motor Vehicle Act, and the need to obey law.
- To impart knowledge about the safety tips to children, pedestrians, cyclists.
- To raise awareness about safe driving.
- To raise awareness about the need to save lives by rushing victims of road mishaps for medical care.
- To raise awareness about the legal protection to Bystander/Good Samaritans.

The following activities were carried out under the project "One Life" Road Safe Awareness Campaign:

1. Awareness about road signs

- a. Mandatory road signs
- b. Cautionary road signs
- c. Informatory road signs
- d. Road markings

e. Provisions in Motor Vehicles Act, 1988 regarding road signs.

2. Awareness about safety

- a. Proper lane etiquette
- b. Use of cell phones during driving
- c. Caution at night
- Retro reflective/reflective tape at the back of vehicles
- Narrow/rural roads merging with highways
- f. Overloading
- g. Precautions to be taken on unmanned Railway Crossing
- Safe cycling tips
- Safety tips for Pedestrians
- Safety tips for school children

Awareness about offences and punishments under Motor Vehicle Act.

Safe driving behaviours

- Awareness camps for the employees working in organizations including call centres for enhancing safe driving behaviours.
- Awareness camps for drivers of public transport and auto drivers which included sensitization on:-
- 1. Proper lane driving
- Offences and penalties under Motor Vehicles Act
- Aggressive driving
- Distracted driving
- 5. Overloading
- 6. Proper parking

Awareness about legal protection to Bystander/Good Samaritans.

Strategy

To successfully carry out the Campaign, District Legal Services Authorities adopted the following strategy under the aegis and guidance of Haryana State Legal Services Authority:-

- 1. The District Legal Services Authorities formed teams of panel lawyers and Para-Legal Volunteers in their respective districts. Workshops for the said panel lawyers and PLVs were held by each of the District Legal Services Authorities to apprise them in detail about this programme on road safety. In the workshops, Panel lawyers and PLVs were apprised about the road signs, safe driving behaviours, tips to be imparted to cyclists, pedestrians and children, need to help the road accident victims, provisions of Motor Vehicle Act and law for the protection of bystanders who help road accident victims. The Panel Lawyers and Para-Legal Volunteers further carried out the awareness campaign in villages, schools etc.
- NGOs having credible reputation in the field were identified, and appropriate tasks in accordance with the objectives and activities of this project were carried out with the identified NGOs.
- Cities, villages, schools and colleges were identified by District Legal Services Authorities, and awareness camps were held at these places.
- A drive for spreading awareness about Retro reflective/reflective tape at the back of vehicles was held in co-ordination with the police of concerned area.
- 5. Special Awareness Camps were held for the drivers of Haryana Roadways State Transport. In this regard, necessary co-ordination was made with General Managers. Experts were engaged to impart awareness about the safe driving behaviours, need to obey road signs, speed limits and the law. Important provisions of Motor Vehicle Act were also explained to the drivers.
- Special Awareness Camps were also held for the employees working in Business organizations and Call centres and also for auto drivers about the need to enhance safe driving behaviours, need to obey road signs, speed limits

and the law. Important provisions of Motor Vehicle Act were also explained to the participants/employees.





SPECIAL DRIVE FOR UNORGANIZED SECTOR WORKERS IN DISTRICT MEWAT

Mewat is one of the most backward districts of Haryana. In terms of several vital socio-economic parameters, it falls way behind other parts of the country, despite being a part of the prosperous state of Haryana. This district is in the grip of poverty. Major part of the population is engaged in agriculture and labour activities. Due to the developmental projects like construction of Kundli-Manesar-Palwal Express Way, construction of Check Dams in Arawali Hills, construction of District Headquarters etc. at Nuh, the concentration of labour engaged in construction industry is more in the region situated on the periphery of Nuh spreading from village Rojka meo to Nuh. District Legal Services Mewat noticed that there was not even a single registration office of the Labour Department in Mewat District. Benefits of most of the welfare



schemes of labour Department flow only when workers are registered. Keeping in view all this, special drive was launched in District Mewat for making people aware of the welfare schemes of labour department, and to help them get registered so that they start getting the benefits of labour welfare schemes. This special drive was held from 1st June, 2016 to 15st June, 2016 to effectively and meaningfully implement NALSA (Legal Services to

the Workers in the Unorganized Sector) Scheme, 2015.

In the first phase of special drive, 30 villages namely Tain, Ghasera, Rehna, Biwan, Shok, Muradbas, Khedla, Salamba, Rojka Meo, Bichor, Jharokdi, Rewasan, Khod, Basai, Dirduka, Mahon, Mahrola, Bainsi, Shahpur Nagli, Badka, Rithoda, Adbar, Danduka, Bajadka, Alduka, Chapera, Kurthla, Baupur, Tapkan and Meoli were selected. All these 30 villages were visited by Secretary, DLSA, Mewat. Camps were organized in the identified villages. The participants therein were made aware about the schemes of Labour Welfare Board meant for the benefit of workers. On 15th June, 2016, a program titled as "Rastariya Majdoor Adhikar Sammelan" was convened. It was attended by about 1500 people. They were not only made aware about their rights under various welfare schemes of Labour Department but were also sensitized and made aware about the welfare policies carried out by other departments of the government.

Besides the stall of department of labour, around 12 other departments including the Departments of Education, Agriculture, Horticulture & Soil Conservation, Forest, Ayush, Dakshin Haryana Bijli Vitran

OBJECTIVES OF NALSA (LEGAL SERVICES TO THE WORKERS IN THE UNORGANIZED SECTOR) SCHEME, 2015

- To institutionalize essential legal services to all unorganized workers.
- To get the gaps in legislation/implementation plugged through coordination with government authorities and by initiating public interest litigation.
- To mobilize the machinery of the State Government and the District Administration to identity and register all unorganized workers in all categories and to extend the benefits of all governments schemes, as applicable to them.
- To spread awareness among the employees regarding the statutory provisions and the need for providing decent working conditions, living wages and social security to the workers.
- To disseminate information among the workers regarding their entitlements under the existing legislations and schemes.
- To provide counseling and assistance to all categories of unorganized workers for their registration with the concerned authorities under the schemes available for their category.
- To assist the workers in availing the benefits of the scheme for which they are registered as per their need/entitlements.

Nigam, Social Welfare, Health, Red Cross & District Information Technology Society Department, Rural Development, Mewat Development Agency, Women Protection Officer etc. and some NGOs namely S.R.F. Foundation, Sehgal Foundation, Care Trust, Digital Empowerment Foundation(CIRC), manifested their core activities meant for the lower strata of public at large by installing stalls. Officers of the various departments made people aware of the welfare scheme of their respective departments. Under this drive, till 15th June 2016, 569 workers were registered with the labour department. In this special drive, Labour Department also co-ordinated with District Legal Services Authority, Mewat.



AWARENESS CAMPS AT VILLAGES

District Legal Services Authority, Panipat organized various legal awareness camps at villages Garhi Chajju, Garhi Tyagyan, Hathwala, Baroli, Saudapur, Khukhrana, Aasan Kalan, Aasan Khurd, in the months of June and July, 2016. The idea behind organizing camps at these villages was to reach out to people living in the remotest area and make them aware about the functions of the Legal Services Authorities. The villagers were explained in detail the concept of legal aid. This apart, the rights under various laws were explained in a comprehensible language to the villagers.

AWARENESS ABOUT FUNDAMENTAL DUTIES

A democratic polity can never succeed where the citizens are not willing to be active participants in the process of governance by assuming responsibilities and discharging citizenship duties and coming forward to give their best. Article 51 (A) of the Constitution of India spells out the various Fundamental Duties of every citizen of India. It is important to discharge the Fundamental Duties. DLSAs under the aegis of HALSA hold camps with an objective to spread awareness about the need to perform the Fundamental Duties for the growth of our country. In the months of June and July, 2016, several camps were held across the State of Haryana to spread awareness about the Fundamental Duties. The copies of the booklet on Fundamental Duties were also distributed amongst the students.



IMPLEMENTATION OF "NALSA

(Child Friendly Legal Services to Children and their Protection)

SCHEME, 2015

Haryana State Legal Services Authority (HALSA) is implementing NALSA (Child Friendly Legal Services to Children and their Protection) Scheme, 2015.

Under this Scheme, special drive was carried out by District Legal Services Authority, Narnaul under the aegis of HALSA, for Child Rights in District Mahendergarh. One of the objectives of the special drive was

to spread awareness about rights of Children. Effort was also made to identify children aged between 6-14, who were not being imparted education. 222 such children were identified. The matter was taken up with the District Education officer of the District to get such children admitted in schools. District Legal Services Authority, Narnaul is regularly following the matter so that Fundamental Right of Children to get education is realized.



Special legal awareness camps under this drive were organized to spread awareness about the



Child Labour (Prohibition and Regulation) Act, 1986, the Prohibition of Child Marriage Act, 2006 and the Right of Children to Free and Compulsory Education Act, 2009.

Child Labour elimination programme was also conducted under this special dirve. In this regard, co-ordination was done with labour department, and teams were constituted to identify children engaged in child labour.

On 27.7.2016, Awareness Programme/Seminar relating to "NALSA (Child Friendly Legal Services to Children and their Protection) Scheme, 2015 was held in Auditorium Hall, Narnaul. It was attended by about 800 people including students and teachers.

Shri Arun Kumar Singal, District & Sessions Judge-cum-Chairman, DLSA, Narnaul apprised gathering about the Constitutional provisions with respect to the Rights of Children. He also highlighted provisions of law regarding Child Labour and the Free and Compulsory Education of Children. He also impressed upon the participants to save girl child and protect children.



On this occasion, 21 students presented a play on the topic of Female Foeticide. The play focussed on female foeticide and broadly aimed at giving out a message to save girl children. WORKSHOP ON PREVENTION OF SEXUAL HARASSMENT OF WOMEN AT WORKPLACE



A workshop "DIGNITY" on Prevention of Sexual Harassment of Women at workplace was conducted for the female lawyers and female employees working in the District Courts, Gurgaon. It was organized by District Legal Services Authority, Gurgaon under the guidance of Sh. Harnam Singh Thakur, District & Sessions Judge-cum-Chairman, District Legal Services Authority, Gurgaon. The workshop was attended by approximately 60 female advocates and female employees who work as stenographers and clerks in the Courts. Important provisions of Sexual Harassment of Women at Workplace (Prohibition, Prevention and Redressal) Act were explained and highlighted in the workshop.

AWARENESS CAMPS REGARDING ILL-EFFECTS OF DRUGS AND PROVISIONS OF NARCOTIC DRUGS AND PSYCHOTROPIC SUBSTANCES ACT, 1985

Ten Special Awareness Camps to spread awareness regarding ill-effects of drugs, provisions of narcotic drugs and psychotropic substances Act, 1985 were organized in different schools by District Legal Services Authority, Panchkula.

Lectures were given to the students and teachers about the ill-effects of drugs and various provisions of NDPS Act 1985.

Incharge, Drug De-addiction Centre, Senior Medical Officer, General Hospital, Sector-6, Panchkula imparted knowledge to the panel advocate about the ill-effects of drugs.

VISIT TO DISTRICT LEGAL SERVICES AUTHORITIES

The important changes brought by Juvenile Justice Act, 2015 were highlighted and discussed in the said workshop. The various provisions relating to child in conflict with law and children in



need of Care and Protection were also discussed. The provisions relating to rehabilitation and social reintegration of children in conflict with law and those in need of Care and Protection were also discussed in the workshop. It was emphasized that all Child Care Institutions are to be mandatorily registered under the Act within six months from the date of commencement of the Act.


