On this occasion Sh. Lalit Batra, D&SJ-cum-Chairman, DLSA, Kurukshetra, Sh. Deepak Gupta, D&SJ-cum-Member Secretary, HALSA, Sh. Sumit Garg, CJM-cum-Secretary, DLSA were also present along with



other Judicial Officers, Officers of the District Administration and Advocates of the District Bar Association.



In his address, Hon'ble the Chief Justice referred to the significance of the historical land of Kurukshetra. His lordship laid stress upon the mediation effectuated by Lord Krishna during the battle of Mahabharata and impressed upon the necessity to resort to process of mediation in order to settle the present day disputes. Hon'ble the

Chief Justice thus referred Kurukshetra to be an extremely important place to have a pilot project of settling dispute through Alternative Dispute Resolution mechanism.

His Lordship also stressed on the positive and important role which the Advocates can play in the mediation process while dispelling all doubts in the mind of the general public regarding the mediation process.

Hon'ble Mr. Justice Jasbir Singh emphasized in his address on the need to combat pendency by making an effort to settle the disputes amicably which would help in bringing litigation between the parties to an end.



Hon'ble Mr. Justice S.K.Mittal apprised the gathering that as per the decision taken by the National Legal Services Authority, ADR Centres are being set up in every District of the State where all modes of Alternative Dispute Resolution would be effectuated under one roof. His Lordship also informed about Legal Care and Support Centres which have been set up in 41 villages of the District to cater to the legal requirements of the people residing in those particular villages and the adjoining villages.

Hon'ble Mr. Justice R.K.Garg motivated the Judicial Officers and the Advocates to continue their work with zeal to bring improvement in the existing system and the settlement process. Shri Lalit Batra, Chairman, DLSA extended vote of thanks to all the dignitaries and others present there.



The function was attended by a huge gathering comprising of Advocates, Law Students, Sarpanches, Anganwari workers and the villagers of nearby areas.

## SECOND PROGRAMME OF AWARENESS REFERRAL COACHING & MENTORING CONDUCTED IN DISTRICT-GURGAON BY MEDIATION AND CONCILIATION PROJECT COMMITTEE (MCPC)

District Gurgaon has been identified by Mediation and Conciliation Committee of Supreme Court of India as a part of its pilot project for conducting Awareness Referral Coaching and Mentoring (ARCM) programme. The first programme was conducted on 18<sup>th</sup> and 19<sup>th</sup> January, 2014 which was a huge success. It was followed by the second programme conducted in District Court Complex, Gurgaon on 1st and 2nd March, 2014 in which MCPC nominated Judicial Officer Trainer Sh. Rajiv Mehra and Advocate Trainers Ms. Nagina Jain, Sh. Deepak Dhingra and Ms. Monika Jalota came for conducting the programme.



The training was conducted in four sessions on 01.03.2014 and two simultaneous sessions on 02.03.2014. These trainers gave Advocate mediators a fair insight into the kind of cases that are referred and gave guidance to them by monitoring them in separate mediation sessions as to how they can prepare the parties for settlement.

A joint programme was also conducted by the trainers for Lawyers of Districts including Law Students from University Institute of Law and Management and K.R. Manglam University, Gurgaon in order to spread its benefits to the public at large.

Dr. Shekher Dhawan, Ld. District & Sessions Judge, also shared his experiences and gave valuable tips to the Judicial Officers in order to conduct effective mediation. During this ARCM programme, 36 cases were taken up, out of which two cases were settled and 7 cases reached at the final stage of settlement.





## SPECIAL TRAINING OF 2<sup>ND</sup> & 3<sup>RD</sup> BATCH OF NODAL OFFICERS OF GOVERNMENT SENIOR SECONDARY SCHOOLS-KAITHAL

After the success of the training of First Batch of Nodal Officers (Block Rajound) of Government Senior Secondary School, the District & Sessions Judge, Kaithal conducted training of Second Batch of Nodal Officers of Government Senior Secondary Schools of the District in the Conference Hall of Judicial Court Complex, Kaithal on 25.01.2014.

This Batch was attended by 31 Lecturers and Teachers. Sh. Gagandeep Mittal, CJM-cum-Secretary, DLSA Kaithal told the Nodal Officer about the working of DLSA, the importance of legal awareness at the initial stage i.e. at school level and the role which Nodal Officers could play in achieving this aim. The training session was also attended by Sh. Shamsheer Singh Sirohi, District Education Officer and Sh. Suresh Gulshan, Principal, Government Sr. Sec. School, Sh. Ashok Bhatt, District Co-ordinator of Nodal Officers.

Thereafter 3rd Batch of Nodal Officers of Govt. Sr. Schools of Guhla, Siwan and Kalayat blocks was called for training on 1st March, 2014 which was attended by 26 teachers of the schools situated in these blocks.

## DIVISIONAL LEVEL COMPETITION UNDER LEGAL LITERACY MISSION OF GOVERNMENT SCHOOLS ORGANIZED FOR ROHTAK DIVISION

On 26.2.2014, a Divisional Level Competition under Students Legal Literacy Mission was organized in the Campus of Government Girls Sr. Secondary School Modal Town, Rohtak with the aim of creating legal awareness amongst the students. In this competition, teams of five districts viz. Rohtak, Sonapat, Panipat, Karnal and Jhajjar participated.
