

- Promotion orders shall be effective from the date of assuming the charge of new assignment by the officials.
- The officials promoted to the posts of Deputy Superintendents (mentioned at Table-II & III) are directed to supervise all the duties of Assistants already assigned to them in addition to their own duties as Deputy Superintendent till the posts of Assistants are filled up or till further orders.
- The officials (mentioned at Sr. No.10 in Table No.II and officials mentioned at Sr. No.16, 17 & 18 in Table-III) promoted to the posts of Clerks from Group-D posts shall have to undergo State Eligibility Test in Computer Appreciation and Applications (SETC) within the period of probation of one year extendable by one year and will not be entitled to earn any increment in their pay matrix till they qualify the said test, failing which they will be reverted back as provided under Rule 10 of Haryana Legal Services Authority Group B, C and D Employees (Recruitment and Conditions of Services) Rules, 2016 and the instructions issued by the Haryana Government from time to time in the subject matter shall also be applicable upon the officials.


