The engagement of lawyers as well as office staff shall be for a period of 2 years (extendable year to year based on the performance).

The duly filled applications form (**Annexure B**) alongwith self-attested copies of documents be submitted through speed-post or in person latest by 27.09.2023 before 5:00 p.m. in the office of Chief Judicial Magistrate-cum-Secretary, District Legal Services Authority, wherein, the candidate desires to apply. Candidates already engaged as Legal Aid Defence Counsels are eligible to reapply for a post higher than they are holding in Districts where the vacancies are re-advertised as above (if they are eligible for the post).

Any incomplete or application form received after due date shall not be considered. Merely, applying for the engagement doesn't create any right or assurance in favour of the candidates.
