Candidates already engaged as Legal Aid Defence Counsels are eligible to reapply for a post higher than they are holding in Districts where the vacancies are re-advertised as above (if they are eligible for the post).

Any incomplete or application form received after due date shall not be considered. Merely, applying for the engagement doesn't create any right or assurance in favour of the candidates.
