It is stated that the sub clause 'v' of clause '3' (3.v) is amended as under:-

The words "within 7 days" are substituted with "within 3 months".

After the sub clause 'v' of clause '3' (3.v), the sub clause (a) shall be inserted, namely:-

v(a): "In case of any delay in the submission of medical claim for more than 3 months, the relaxation will be given by the Administrative Secretary of Health Department in consultation with Finance Department."
