
Haryana Government Health Department Notification

Dated Chandigarh the 03.03.2022

No. 46/06/2022-5HB-II Whereas the Governor of Haryana is satisfied that the State of Haryana is threatened with a possible outbreak of a dangerous epidemic disease namely Influenza A H1N1, and the ordinary provisions of law for the time being in force are insufficient for the purpose. Now, therefore, in exercise of the powers conferred by Section 2.1,3 & 4 of the epidemic diseases Act 1897, the Governor of Haryana is pleased to make the following regulations for the 3 Years (ie. F.Y. 2022-23,2023-24 & 2024-25):-

- 1. These regulations may be called the Haryana Epidemic Diseases, Influenza A H1N1 Regulations, 2019.
- 2. In these regulation, unless the context otherwise requires, "Epidemic Diseases, Influenza" means Influenza A H1N1.
- 3. All Hospitals (Govt./Private) will follow the categorization of Influenza A H1N1 issued by the Government of India and available at the website of NCDC (National Centre for Disease Control, New Delhi).
- 4. Isolation Centre means any place which may be declared by concerned Civil Surgeon where Influenza A H1N1 Suspected/Confirmed cases may be admitted for Treatment and Sample Collection for Influenza A H1N1.
- 5. All Hospitals (Government and Private) to inform the Health Department of Haryana through respective Civil Surgeons immediately about all cases of ILI (Influenza like illness) in category-B of Influenza H1N1 and about a Confirmed Case of Influenza A H1N1 being reported in their institution should be put on treatment as per Protocol and Guidelines of Government of India without waiting for the laboratory results of such cases.
 - a) The detail of the Nodal Officers of State and District with their contact numbers and email address for reporting has been uploaded on website of Health Department Haryana (haryanahealth.nic.in)
- 6. All cases of Influenza A H1N1 whether Suspected or Confirmed should be kept in isolation to avoid any spread of the disease.
- 7. All Hospitals/Medical Colleges should have Screening Centres (Flu corner) so that the ARI/IL I patient is screened at the earliest.
- 8. The recommended test for confirmed diagnosis of Influenza A H1N1 by RT PCR method will only be accepted to be done by Government designated Labs.
- No Person/Institution or Organization will spread any information or material for management of Influenza A H1N1 without prior permission from Health Department Haryana.
- 10. No Person/Institution or Organization will use any print or media in any form for Influenza A H1N1 without prior permission from Health Department Haryana.
- 11. Notice for disobeying the notification: A committee under the Chairmanship of Civil Surgeon will be constituted in each District, which will have Medical Specialist, Pediatrician, Anesthetist and District Epidemioligist as member to review anydisobeying/deviation done by any Person/Institution or Organization against regulation or order made under this act. If disobeying is proved, a notice will be issued by the Civil Surgeon of the concerned District against the Person/Institution or Organization indicating the offence/irregularity conducted as per this notification, a copy of the notice will be sent to Civil Surgeon of the concerned District.
- 12. The reply of the Person/Institution or Organization received against the notice will be reviewed by the above said District Committee. If reply is not received within stipulated time of receipt of the notice or if the reply found unsatisfactory by the committee members and it is confirmed that the Person/Institution or Organization has disobeyed the regulations under this notification, The Civil Surgeon of the District is to take action against the concerned Person/Institution or Organization as per section 3 of Epidemic Disease Act section 11 of these regulations.

- 13. Penalty: Any person/s institution or organization disobeying any regulation or order made under this act shall be deemed to have committed an offence punishable under section 188 of Indian Penal Code (45 of 1860). District Administration can Penalize Person/Institution or Organization found disobeying the regulations or orders made under this act.
- 14. Protection to person acting under Act: No suit or legal proceeding shall lie against any person for anything done or in good faith intended to be done under this Act.
- 15. This regulation shall come into force at once and shall remain valid for three years from the date of publication.
