Guidelines for running of Clinical Laboratories in Haryana. Subject:-

The State Government has framed the following Guidelines for running of clinical 1. laboratories in Haryana:-

- The minimum qualification required for signing of Clinical Lab reports is MBBS. It is i. open to any person or institute to run a Clinical laboratory but only if such Clinical laboratory engages a doctor possessing qualification of MBBS or above who are registered with the Medical Council India or State Medical Council as per Indian Medical Council Act 1956 (referred here under as Registered Medical Practitioner) for signing of the Laboratory Reports.
- ii. The qualified Laboratory Technicians and any other staff with B.Sc/M.Sc/PhD degrees etc. in Medical Lab Technology are allowed to conduct lab tests as per their qualification. They cannot issue signed laboratory report without authentication of the same by Registered Medical Practitioner.
- iii. The Government of India Guidelines issued under various National Programmes for conducting tests by the paramedical staff shall continue to be followed in Government Health Care Institutions under the supervision of qualified Registered Medical Practitioners.

These Guidelines shall be applicable to all Government and Private clinical 2. laboratories/ establishments in the State.
