2. In continuation to this office Letter No.2PM-Cashless-2017/13626-13786 dated 20.11.2017 and 2PM-Cashless-2018/2158-2318 dated 04.04.2018, on the subject cited above.

3. I have been directed to state that in addition to the six threatening medical conditions, already notified by State Government under Limited Cashless Medical Facility, the State Government has decided to include COVID-19 as well, for Haryana Government Employees, Pensioners/Family Pensioners and their dependents. The private empanelled hospitals would levy charges, as per the existing reimbursement/limited cashless/empanelment policies, as the case may be, issued by State Government and amended from time to time. The bills against the treatment provided would be submitted to DDO's of concerned department for reimbursement.
