The appointment is further subject to the following conditions:-

1. The candidature of concerned Dental Surgeon will be cancelled automatically without any notice/information in case, the certificates/documents are found to be bogus at any stage.
2. They will be entitled to draw such allowances and other benefits as sanctioned by the Government of Haryana from time to time.
3. The post is temporary and likely to continue and their appointment will be terminable on one month notice on either side while they are born on the temporary cadre. This condition will, however, not be applicable in case their services are dispensed with during probation period.
4. They will be on probation for a period of two years from the date of joining which can be extended, if necessary, up to three years. The completion of two years service on probation will not itself entitle them for confirmation unless post is substantively vacant.
5. If so required, the Dental Surgeon shall be liable to serve for confirmation in any Defence Service or post connected with the defence of India for a period of not exceeding four years including the period spent on training if any, provided they:
  - a) Shall not be required to serve as aforesaid after the expiry of ten years from the date of appointment, and.
  - b) Shall not originally be required to serve as aforesaid after attaining the age of forty five years.
6. The services of Dental Surgeons will be governed by the **Haryana Health Department Dental (Group-B) Service Rules, 1987** as amended from time to time. In respect of pay, leave, pension and other matters not expressly provided for in the **HCDS-II Rules**, they shall be governed by such regulations and rules as have been framed or may hereafter be adopted by the Competent Authority under the Constitution of India.
7. On joining, they will be required to take on Oath of Allegiance to the Constitution of India.
8. They will be required to submit following undertaking alongwith the joining report:-
  - a) A declaration attested by First Class Magistrate to the effect that he/she has only one living spouse and is not married to a person already having one living husband/wife.
  - b) A declaration that he/she was not dismissed from service on any occasion under any department of Govt. or convicted by a court of law.
9. The seniority will be determined according to their position in the merit list as sent by the Haryana Public Service Commission.
10. They are liable to be transferred anywhere within or outside the State of Haryana.
11. They are required to furnish a Medical Certificate of fitness before joining from the Medical Board constituted under rule 9 of the Haryana Civil Services (General) Rules, 2016. Thus have to appear for the medical examination in the office of any Civil Surgeon of Haryana State except:-
  - (1) When declared medically fit in the last 06 months by the Medical Board, Haryana.
  - (2) When already employed elsewhere on a gazetted post under the Haryana Govt. and had produced a medical certificate to the department, provided there is no break in the service and a certificate from the employer has been submitted to this effect.
12. The appointment is provisional and is subject to the verification of the eligibility conditions such as academic qualifications certificates and any other certificates

- such as Scheduled Castes/Scheduled Tribes/Backward Classes/ESM/DESM if any, submitted by them. If on verification, it reveals that the information given by them is false, then their services will be terminated/dispensed forthwith without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate.
13. This offer of appointment is further subject to condition of verification of character and antecedents. The services will be dispensed with at once without any notice, if he/she is not of good character and anything is found adverse against him/her.
  15. It may be noted that if any candidate qualified in the above result is falling under the purview of investigation relating to FIR No. 4 of 2021 dated 17.11.2021 U/S 7, 7A of Prevention of Corruption Act, 1988, 420, 466, 468, 477, 120 B (IPC) & 8(3)(4) of the Haryana Public Examination (Prevention of unfair means) Act, 2021 in PS, SVB, Panchkula, his/her candidature would be purely on provisional basis and subject to final outcome of the said case.
  14. This offer of appointment is subject to the final outcome of CWP No 20552, 20839, 20848, 22184, 20560 & 18922 of 2022 etc. pending before the Hon'ble Punjab and Haryana High Court.
  15. If selected Dental Surgeon are willing to accept this offer of appointment on the above mentioned terms and conditions, he/she should report to the concerned Civil Surgeon for joining duty within 30 days from the date of receipt of this letter, **no extension in joining time would be allowed**. If he/she fail to report for duty within stipulated period, it will be presumed that he/she is not willing to accept this offer of appointment and your candidature will be treated as cancelled.
  16. This appointment is subject to and without prejudice to undertaking as given in lieu of Chief Secretary instructions No. 52/08/2022-3GS II dated 23.06.2022:-
    - a. Attestation form
    - b. Self declaration.
