NOTIFICATION**

Dated, Chandigarh the 28.03.2023

No. 46/04/2020-5HB-II - Whereas the Governor of Haryana is satisfied that the State of Haryana is threatened with a possible outbreak of a dangerous epidemic disease namely COVID-19 . Now, therefore , in exercise of the powers conferred by Section 2,1,3 & 4 of the epidemic diseases Act 1897, the Governor of Haryana is pleased to extend the regulation of 'The Haryana Epidemic Disease, COVID -19 Regulation, 2020 till 31st March 2024 in continuation of previous regulation issued vide Government No.. No.46/04/2020 -5HBII, dated 11.03..2020 with amendments in following points:-

5. All health facilities (Government & Private) during screening of such cases shall record the history of travel of the person if he/she travelled to any country or area where COVID-19 has been reported as per guidelines/ directions of MoHWF,GoI). In additional, the history of coming in contact with a suspected or confirmed case of Covid-19 shall be recorded. Information of all such case should be given to office of Civil Surgeon of the district Immediately.
7. All COVID-19 samples will be collected as per Guidelines of Govt. of India and these will be sent to laboratories designated by the State Government or Government of India .
8. Any person with a history of travel to a country or area from where COVID-19 has been reported, must comply with latest COVID-19 guidelines/direction from MoHWF, GoI.
12. District Disaster Management Committee headed by Deputy Commissioner is authorized for planning strategy regarding containment measures for COVID-19 in their repective Districts. The Deputy Commissioner may co-opt more officers from different departments for District Disaster Management Committee for this activity under these regulations.

Point no. 11 shall be obliterated .

The remaining conditions in the previous notification dated 11th March,2020 shall remain unchanged.
