**Sir/ Madam**

I have been directed to draw your kind attention towards the subject and state that Government of Haryana has allowed medical reimbursement for the charges incurred upon the treatment for COVID-19 of State Government employees/ pensioners/ family pensioners and their dependents at any dedicated COVID hospital, with the exemption of producing the emergency certificate. The medical bills for treatment of COVID-19 at unapproved hospital shall be reimbursed at par with the rates approved under the State Government reimbursement policies and guidelines issued from time to time; a ready-reckoner for the same is tabulated below:
