**Subject: Regarding fixation of rates for Government Employees, Pensioners and their dependents for COVID-19 treatment.**

Sir/Madam,

I have been directed to draw your kind attention to the subject cited above and state that in view of the additional cost of personal protection equipment (PPE) involved in the management of COVID-19 patients and considering the recommendations of the Committee chaired by Dr.V.K.Paul, Member, NITI Aayog; State Government has allowed an amount of Rs.1200/- per day for Isolation ward and Rs.2000/- per day for ICU, as cost of consumables (PPE kits), only in cases of COVID-19 treatment.

It is clarified that the Government employees, pensioners and their dependents may avail COVID-19 treatment facilities at private hospitals/medical colleges, empanelled with State Govt. as per existing Reimbursement (1340 fixed package rates dated 14.07.2020)/ Limited Cashless Medical Facilities/ Empanelment policies, as the case may be, and shall be charged accordingly.

This is applicable for the treatment of COVID-19 cases only.

This is issued with the approval of competent authority & concurrence of Finance Department vide their U.O. No. 20318-2FD-II(A)/2020 dated 07.10.2020, and come into force with immediate effect.
