Subject: Hepatitis B vaccination of Health Care Workers (HCWs).

In reference to the subject cited above, it is communicated that 5,30,000 doses of Hepatitis B vaccine have been allocated to the Haryana State for vaccination of Health Care workers (Annexure-1) and district wise allocation of vaccine is attached as annexure-2. Further, it is communicated that vaccine allocated to the district include the vaccine for HCWs of State Govt./State Govt. aided Medical & Dental Colleges situated in the district. In this regard, you are requested to follow the below given directions:

- 1. Ensure that all HCWs of Health Department Haryana and NHM Haryana including ASHAs and staff involved in sanitation & bio medical waste handling should be vaccinated, and it include contractual as well as outsourcing staff.
- 2. Utilize the already existing system for the collection, storage and supply of this vaccine under UIP, and there is no need to segregate the stock physically for Health Care Workers vaccination and UIP. The District Immunization Division should maintain the record of vaccine issued for HCWs.
  - 3. Infection Control Nurse (ICN) designated at Health Facility will do the vaccination and a separate register as per the standard reporting format (Annexure-3) shared by NVHCP Division will be maintained for record keeping. In the health facility, where ICN is not available, the vaccination will be done by the ANM who is doing routine immunization and will maintain the record as per standard reporting format (Annexure-3). The monthly report will be shared by the districts with State HQ regularly.
  - 4. DSO's to ensure that the data of all HCWs vaccinated for Hepatitis B in their concerned district is entered in NVHCP MIS portal
  - 5. Vaccination Card as per Annexure-4 should be issued to every HCWs.
