Subject: Hepatitis B vaccination of Health Care Workers (HCWs).

In reference to the subject cited above, it is communicated that Hepatitis B vaccine has been allocated to Haryana State by Govt. of India for vaccination of Health Care workers. In this regard you are requested to:

- Ensure that all HCWs of your Medical/Dental College including staff involved in sanitation & bio medical waste handling should be vaccinated, and it include contractual as well as outsourcing staff also. The required doses of Hepatitis B vaccine may be collected from Immunization Division, O/o Civil Surgeon of the district in which your Medical/Dental College is situated.
- 2. Utilize the already existing system for the collection, storage and supply of this vaccine under UIP, and there is no need to segregate the stock physically for Health Care Workers vaccination and UIP.
- 3. Maintain the record of vaccine issued for HCWs and share the monthly report with State HQ and Immunization Division of concerned District as per Format attached. (Annexure-1)
- 4. Designate a Nodal Officer for coordination with Immunization Division of the concerned district and vaccination of HCWs in your Medical/Dental College. The name and contact details of Nodal Officer should be shared with State HQ (nvhcpharyana@gmail.com) and concerned district.
- 5. Designate a room for HCWs vaccination. Infection Control Nurse (ICN) designated at Health Facility will do the vaccination and a separate register as per the standard reporting format (Annexure-1) shared by NVHCP cell will be maintained for record keeping. In the health facilities where ICN is not available, the vaccination will be done by the ANMs/staff nurse who is doing routine immunization and will maintain the record as per standard reporting format.
- 6. Vaccination Card as per Annexure-2 should be issued to every HCWs.
