**Subject: Provisional Appointment to the post of Medical Officer (Waiting list)
in Health Department Haryana.**

On the recommendation of the Departmental High Powered Selection Committee, the Governor of Haryana is pleased to offer the appointment as Medical Officer to the following candidates in the Health Department, Haryana on purely provisional basis subject to the conditions mentioned in Chief Secretary, Haryana letter No. 52/08/2022-3GS III, dated 23.06.2022, in FPL-10 as per 7th pay commission starting Rs. 56100/- per mensem plus other allowances as admissible from time to time and are also hereby posted at the station mentioned against their name:-

This appointment is further subject to the following conditions:-

01. The candidature of concerned Medical Officer will be cancelled automatically without any notice/intimation in case, if the certificates/ documents are found to be bogus at any stage.

02. They will be entitled to draw such allowances and other benefits as sanctioned by the Government of Haryana from time to time.
03. The appointment will be terminable on one month notice on either side while the candidates are in the temporary cadre. This condition however, will not be applicable in case the services of concerned Medical Officer is dispensed with during the probation period if his/her work or conduct is not found satisfactory.
04. The Medical Officers will be on probation for a period of two years from the date of joining which can be extended, if necessary up to three years. The services put in against the temporary post might be counted towards the period of probation but the completion of two years temporary services will not in itself entitle them for confirmation unless the post is substantively vacant. The service during probation period can be terminated without assigning any reasons or giving any notice.
05. If so required, the Medical Officers shall be liable to serve in any Defence Service or post connected with the Defence of India for a period not exceeding four years including the period spent on training if any, except:-
 - (a) After the expiry of ten years from the date of appointment and
 - (b) After attaining the age of forty five years.
06. The services of Medical Officers will be governed by the Haryana Civil Medical Services (Group A) Service Rules, 2014 as amended from time to time. In respect of pay, pension, leaves and all other matters not expressly provided for in the Health Department Haryana Rules, the services of Medical Officers shall be governed by such regulations and rules as have been/would be framed or may hereafter be adopted by the Competent Authority under the Constitution of India.
07. The Medical Officers will be required to take an oath of allegiance to the Constitution of India on appointment/joining.
08. The Medical Officers will be required to submit following undertaking alongwith the joining report:-
 - A declaration attested by First Class Magistrate to the effect that he/she has only one living spouse and is not married to a person already having one living husband/wife.
 - A declaration that he/she was not dismissed from service on any occasion under any department of Govt. or convicted by a court of law.
 - In case, he/she is married, he/she will have to file a declaration that he/she did not give/accept dowry during the marriage. If he/she is unmarried, he/she will have to furnish a declaration immediately after marriage regarding non acceptance/giving of dowry by him/her as per declaration in Annexure A and B in terms of Government instructions issued vide No. 18/1/2004-2GSI dated 21.02.2006.
09. The seniority of the selected Medical Officers will be determined according to the position in the merit list prescribed by the Departmental High Powered Selection Committee.

10. The Medical officer is liable to be transferred/deputed anywhere within or outside the State of Haryana.
11. The Medical Officer is required to furnish a Medical Certificate of fitness from the Medical Board constituted under Rule 9 of Haryana Civil Services (General) Rules, 2016 before joining. He/She has to appear for medical examination in the office of any Civil Surgeon of Haryana State except that :-
 - (i) He/she is declared medically fit in last 06 months by the Medical Board, Haryana.
 - (ii) He/she is already employed somewhere on a gazetted post under the Haryana Government and he/she has already produced a medical certificate to the department, provided there is no break in the service and he/she has produced the certificate from his employer to this effect.
12. The appointment is provisional and is subject to the verification of academic qualification certificate/ Schedule Castes/ Backward Classes/ ESM/ DESM/ EWS/ DFF certificate or any other document/declaration. If the verification reveals that the claims pertaining to academic qualification/other documents as the case may be, are false, the services will be terminated forthwith without assigning any reason or issuing any further notice and without prejudice to such further action as may be taken under different penal/legal provisions of applicable Act/ Rules or production of false documents.
13. This offer of appointment is further subject to condition of verification of character and antecedents. The services will be dispensed with at once without any notice, if he/she is not of good character and anything is found adverse against him/her.
14. The services of Medical Officer will be dispensed with if the conduct during Probation Period is not found satisfactory.
15. If selected Medical Officer is willing to accept this offer of appointment on the above mentioned terms and conditions, he/she should report to the concerned Civil Surgeon for joining at his/her respective posting station within 15 days. No extension in joining time would be allowed. If he/she fail to report for duty within the stipulated period, it will be presumed that he/she is not willing to accept this offer of appointment and his/her candidature will be treated as cancelled.
16. This appointment is subject to and without prejudice to given undertaking as under as per Chief Secretary Instructions on 52/08/2022-3GS-III dated 23.06.2022:-
 - a. Attestation form.
 - b. Self declaration.
