Consequent upon the decision of Hon'ble Punjab & Haryana High Court given on 19-4-2022 in CWP No 9494 of 2018 titled as Poonam V/s State of Haryana and others and COCP No. 1470 of 2022 Poonam V/S Virat (HCS) Secretary. On the recommendation of Haryana Staff Selection Commission, Panchkula had sent their recommendation No. HSSC/Confid/Recomm./2023/10 dated 03-01-2023, and HSSC/Confid/08/07/ 2023-9CA/2396 dated 18/19-4-2023, Director General Health Services, Haryana on such recommendation is pleased to offer you appointment provisionally to the post of **Staff Nurse(Group -C)** in the office of Health Department Haryana, in Functional pay level **FPL-7** as may be admissible from time to time, on purely provisional basis, subject to condition that in case, your character and antecedents or the documents pertaining to your Essential Qualification, Age, Caste/Category, Universities, Socio-Economic criteria , experience as claimed in the application form are found not verified or any false information is given by you in self declaration, the provisional appointment letter will be cancelled forthwith and criminal/legal action will also be taken, as a consequence:

1. Appointment will be provisional subject to the conditions mentioned in Govt. letter No. 52/08/2022-IIIGS dated 23.06.2022.
2. That in case your certificate/document found fake/bogus, your candidature will be cancelled automatically without any notice/intimation.
3. You will be entitled to draw such allowances and other benefits as sanctioned by the Government from time to time.
4.
