Subject: Regarding empanelment of private hospitals for providing medical facilities to Haryana Govt. employees/pensioners and their dependents.

I have been directed to invite your kind attention towards the subject mentioned above and to state that the State Government has decided to empanel/ to continue empanelment of the following private hospitals for providing treatment to the Haryana Government employees/pensioners and their dependents:-

The above mentioned hospitals are empanelled on the terms and conditions mentioned below:-

1. The empanelled hospitals shall provide seamless & hassle-free services to Haryana Govt. employees/pensioners and their dependents and shall extend all normal courtesies & facilitate the admission, treatment and discharge of Haryana Govt. beneficiaries with no delay or denial of medical facility.
2. A Nodal Officer, whose details are provided by concerned hospital and published on web-portal of Health Department, shall be the responsible person for communication and coordination with State Govt. beneficiaries and departmental officers, for smooth facilitation of services and redressal of any grievance. In case of any change in contact details of the Nodal Officer the same shall be brought into notice of this office immediately.
3. All statutory Acts/ Rules/ Notifications/ Guidelines issued by State Govt. and amended from time to time (As already mentioned in the application form for Empanelment Policy-2023) shall be adhered to by the empanelled hospitals in true letter and spirit.
4. The hospitals shall abide to all the National Programmes and related IEC activities. The data required for national programs or health indicators must be shared regularly with Health Department.
5. The hospitals shall follow the guidelines pertaining to birth & death registration, issued by the State Government from time to time. Any software developed by the Govt. will have to be adopted by the hospitals.
6. The hospital shall also follow the guidelines pertaining to vaccination of new-borns.

7. The guidelines already framed under State Govt. policy regarding reimbursement of medical bills dated 14-07-2020 presently & as revised from time to time for empanelled hospitals shall be applicable.
8. The empanelled hospitals shall provide Limited Cashless Medical Facility notified by State Govt. dated 20-11-2017 and amended on 04-04-2018, 08-03-2021 & 08-06-2021 or to be amended in future.
9. As per Haryana Govt. reimbursement policy dated 14-07-2020, there are two categories of rates to be charged by empanelled hospitals i.e. for Full NABH and for Entry Level NABH hospitals; the hospital shall charge State Govt. beneficiaries according to the level of accreditation of concerned hospital. The same amount would be reimbursable to State Govt. beneficiaries.
10. The hospital will charge Rs. 300/- once in month, as OPD Consultation fees from patients with chronic diseases, as per policy dated 14-07-2020.
11. The hospital will provide 40% discount in OPD Consultation fees to all Govt. employees, Pensioners and their dependents (without chronic diseases) as per policy dated 14-07-2020.
12. All empanelled hospitals will maintain record of the treatment of the patients and Health Department reserves the right to call for record of treatment of any patient from any empanelled hospitals to ensure no mal-practice is being carried or for any others purpose.
13. The above listed **Full NABH hospitals** will remain empanelled for period of **three years** subject to validity of accreditation certificate. Thereafter, the hospitals will apply afresh.
14. The above listed **entry level NABH hospitals** will remain empanelled for period of **two years initially** and on submission of full NABH within that period, the empanelment hospital will be further extended for a period of total three years.
15. It will be the responsibility of the hospitals to provide renewed accreditation certificate before it's expiry as per Govt. Empanelment policy. If the hospital is unable to provide such certificate, the hospital will be de-empanelled automatically.
16. The empanelled hospitals shall abide to all the guidelines of Empanelment Policy and as amended from time to time.
17. In case of any emergency/ disasters /overflow of patients in Govt. Hospitals during epidemics, the empanelled hospitals will share their ambulances, mortuary, ICU/CCU, burn unit, ward, beds, etc. in need based manner.
18. Any private hospital shall be automatically de-empanelled from the list of Haryana Government, if it gets disqualified:
 - a) Under 'The Clinical Establishments (Registration & Regulation) Act, 2010' or corresponding Act applicable in the respective state/UT; and/or
 - b) Under Ayushman Bharat: Pradhan Mantri Jan Aarogya Yojna (AB:PMJAY); and/or
 - c) By NABH/NABL
