Applications are invited from the eligible candidates for the following posts under National Health Mission. Posts are purely on contract basis for a fixed period initially upto 31.03.2025 (extendable, subject to further administrative approval and performance).

• **Post- Ophthalmologist (Sr.No.1)**

Mode of Recruitment:

Walk-In-Drive on Date: 16th, August 2024

Documents Required: Interested Candidates are required to bring their original certificates, one set of (attested/self attested) photocopies of Essential qualification certificates and all other relevant documents on Walk-in Drive on 16th, August 2024 as per eligibility criteria. Candidates are also advised to read the instructions carefully before applying for the post.

Note: If the post of Ophthalmologist remain vacant on the scheduled Walk-in date, then Walk-in Drive will be conducted on every Thursday of the month (till this post is filled).

Important Instructions for candidates: -

1. Age relaxation will be given to the categories as per Haryana Govt. policy and NHM Haryana rules.
2. **No benefit of NHM Service Bye Laws shall be applicable for the new staff hired with reference to instructions issued vide memo no. NHM/Admin/HRC-II/2024-25/2952-72 Dated 23.07.2024.**
3. NHM Selection criteria **(Annexure-A)** issued vide memo no. NHM/Admin/HRC-1/2022-23/10885-905 dated 20.03.2023 shall be followed for recruitment. **It is clarified that no written test/Interview shall be conducted for the recruitment of above said posts under NHM at district level.**
4. Post of reserve category (if any) will be filled up as per Haryana Govt. Reservation Policy.
5. Private practice after duty time and on holidays to staff recruited under NHM is strictly prohibited.
6. A candidate must be in good mental and physical health and free from any physical defect, which is likely to interfere with the efficient performance of the duties required for the post. The appointment shall be subjected to their

- being declared medically fit as per medical fitness standards followed by the Health Department
7. The candidates are required to attach the attested/self attested legible copies of following certificates and relevant documents along with the Application form:-
- I. Valid Document as a proof for Date of Birth (10th certificate/Birth certificate).
 - II. Essential qualification Certificates.
 - III. Mark sheet of each year/Semester.
 - IV. Additional Relevant Post Experience Certificate (if any) issued from (any State Govt./Semi Govt./UT/any Govt. Board/Corporation/NHM) specifying the working on full time basis with complete details like Letter no. and date of issue, Designation, Date of Joining and Date of Resignation, Work details and last Salary drawn etc. **The period of experience rendered by a candidate on part time basis shall not be counted while calculating the valid experience.**
 - V. Two latest passport size-colored photographs.
 - VI. Candidate claiming reservation should submit the copy of latest reserve category certificate issued by the competent authority as per the latest Govt. instructions (if any).
 - VII. Self attested/attested copies of any of the three documents mentioned below as residential proof.
 - a. Passport

8. **The candidates should:**
- (I) **Mark page numbers on the top at right hand side corner of each page and mention the total number of pages in the Application Form.**
 - (II) **Sign all the pages of the Application Form, certificates and documents.**
9. Candidates applying for a post must ensure that they fulfill all the eligibility conditions as on the day of closing date. Ineligible candidates not need to apply.
10. List of provisionally shortlisted eligible candidates will be uploaded on web site i.e. nhmharyana.gov.in and haryanahealth.gov.in after scrutiny of applications. **Candidates are advised to visit the web sites regularly for any corrigendum/notice/ updates/result etc. As no separate call letter/communication in hard copy will be sent to the provisionally eligible candidates on their correspondence addresses.** The application shall be subjected to subsequent scrutiny and can be rejected at any point of time if found incomplete/wrong/not fulfilling the eligibility criteria etc. No correspondence in this regard shall be entertained.

11. Selected candidate shall not have any claim for regularization of his/her services based on the duties performed under this contract, as he/she has been engaged for project financed by Govt. of India having specific tenure.
12. (I) It is clarified that a person/candidate who has been terminated or discontinued from the services of NHM as per the provisions mentioned in NHM Service Bye Laws at clause no.21 (b) & (c), he/she will be treated as disqualified candidate for any fresh recruitment under NHM as per the provisions mentioned in NHM Service Bye Laws at Clause no.9 (2) "Disqualification": No person, who has been dismissed from the Mission under any State or at National level or from the service of the Government of India or any State Government or a local authority, a corporation or institute, shall be eligible for appointment to any post.
(II) No court case/Police enquiry/FIR etc. should be pending against the applicant and he/she should not be convicted by any court.
"Selected Candidates shall submit the declaration regarding the same on legal stamp paper duly notarized".
13. Any instructions issued by Health Department, Haryana/National Health Mission Haryana from time to time will be followed.
14. No TA/DA shall be paid for recruitment process.
15. Number of posts can be increased or decreased.
16. Documents verification of shortlisted candidates will be done by this office. If any candidate is found with false documents at the time of appointment or later stage, his/her appointment/recruitment will be cancelled/terminated immediately without serving any notice and suitable action shall be taken against him/her as per rules/laws.
17. The candidature shall be provisional and will be subject to verification of eligibility conditions with reference to original documents. Screening and selection will be based on the details provided by the candidate. Hence, it is necessary that applicants should furnish accurate, full and correct information in the application form.

Subject: Regarding revision of Selection Criteria for recruitment of posts under NHM on Contractual basis at district level by District Health & Family Welfare Society, Haryana.

It is informed that, various complaints have been received regarding discrepancies in the written examination for the recruitment of various posts under NHM in the Districts. Therefore, the Selection Criteria issued by this office vide letter no: NHM/Admin/HRC-1/2021-22/7591-7652, dated 20.09.2021 is hereby withdrawn with immediate effect.

Accordingly, as per approval from W/Additional Chief Secretary, to Govt. Haryana, Health Department, the selection criteria for the recruitment of posts under NHM at district level has been revised, as mentioned below:-

Instructions:

1. It is clarified that, the recruitment of contractual posts under NHM, *approved in RoP*, should be done with wider publicity in various newspapers through Directorate of Public Relations.
2. It is clarified that no written test should be conducted for the recruitment of posts under NHM at district level. Only selection criteria mentioned above in this letter should strictly be followed for all future recruitments under NHM Haryana. No over & above criteria should be followed for recruitments under NHM at district level.

Additional guidelines for selection criteria are as under:-

- The formula for calculating the marks for Essential Basic qualification (Sr. no 1 of Table-A) will be done by multiplying the percentage of marks obtained by the candidates with weightage and divided by 100.
- 02 marks will be given for each completed year of additional relevant post experience, with maximum of 10 marks for all Posts.
- The Reservation policy of Haryana Government should strictly be followed.

Note:

1. As Deputy Commissioner is the Chairman of District Health & Family Welfare Society, there must be an observer/nominee of Deputy Commissioner for the entire recruitment process, irrespective of the number of vacancies.
