- 2. NHM Selection criteria (Annexure-A) issued vide memo no.NHM/Admin/HRC-1/2022-23/10885-905 dated 20.03.2023 shall be followed for recruitment. It is clarified that no written test/Interview shall be conducted for the recruitment of above said posts under NHM at district level.
- 3. Post of reserve category will be filled up as per Haryana Govt. Reservation Policy. The candidates belonging to BC-A and BC-B categories are directed to obtain the fresh/latest BC-A and BC-B certificate, as the case may be, as per Haryana Govt. notification no. 40/13/2024-1SW Dated 16.07.2024. OBC certificate shall not be entertained. Only BC-A/BC-B certificate as per instructions detailed above shall be considered. Candidates applying under the quota reserved for PWD must indicate the category they belong to i.e. SC/BC wherever applicable.
- 4. Private practice after duty time and on holidays to staff recruited under NHM is strictly prohibited.
- 5. A candidate must be in good mental and physical health and free from any physical defect, which is likely to interfere with the efficient performance of the duties required for the post. The appointment shall be subjected to their being declared medically fit as per medical fitness standards followed by the Health Department
- 6. The candidates are required to attach the attested/self attested legible copies of following certificates and relevant documents along with the Application form:-
