OFFICE ORDER

The following Divyang MPHW (F) are hereby provisionally promoted as Multipurpose Health Supervisors (F) in the pay scale of FPL-6 from the date of their joining to this post. This promotion is further subject to the following terms and conditions:-

- 1. That in the event of final decision in the disciplinary proceedings which are pending against their seniors, juniors shall have no right on the post of MPHS (F) if their seniors are found fit for promotion after the decision of disciplinary proceedings.
- 2. The promotion shall be without prejudice to the right of their seniors; if any disciplinary proceedings shall be decided in favour of any senior employee then junior most officials will be reverted.
- 3. This promotion is subject to the condition that if any adverse remarks or honesty is found doubtful in any unavailable ACRs of the employees at this time, she/they will be reverted to the post of MPHW (F).
- 4. These promotions have been made strictly in accordance with the provisions in the Service Rules called as Haryana Health Department Multipurpose Health Supervisors and Multipurpose Health Workers Group 'C' Services Rules, 1984.
- 5. These promotions are without prejudice to the pending decision in the Hon'ble Supreme Court/High court or any APEX Court in the matter of reservation in the promotion.
- 6. If at any stage it is found that the employee is/was not eligible to get the promoition under PH category as per Govt. instructions issued from time to time she will be reverted without any notice.
- 7. All the officials will be on probation for a period of one year from the date of their joining on the post of MPHS (F).
