1. Your appointment is provisional subject to the conditions mentioned in Chief Secretary, Haryana

- letter No52/06/2018-2HRIII dated 05.02.2024.
- 2. The post is temporary and your appointment will be terminable on one month's notice on either side or one month salary including allowances in lieu of notice (except in case of removal/dismissal or misconduct) while you are in the temporary eadre. It will however be open to Government to pay in lieu of notice your salary for the period by which the notice falls short of one month and similarly if you wish to resign from the post, you may do so by depositing with Government your salary in lieu of notice for the period by which it falls short of one month.
