
#### ***Important Instructions:***

1. The hiring process of Medical Officer will be Weekly basic (Every Thursday at 11.00 am) till the posts are filled up or whenever fall vacant in ATF, Sonipat. This advertisement is valid till 31/03/2026.
2. All the information regarding recruitment process will be intimated through <https://haryanahealth.gov.in/notice-category/recruitments> website and no separate intimation will be given in this regards.
3. Revised criteria of selection vide MD NHM letter No. NHM/Admin/HRC-1/2022-23/10885-905 dated 20/03/2023 (Letter attached) will be applicable.
4. There will be no interview and written test.
5. Application form can be taken from ATF Office, Civil Hospital, Sonipat
6. Application fee (non-refundable) is Rs. 200/- per application form and separate application will be required for each category of posts. The application form will be rejected if not submitted on the prescribed formats along with receipt of application fee.
7. Weightage of experience will be provided to only those candidates who have experience from any state Govt./ Semi Govt. /UT/any Govt .Board/Corporations. Only those experience certificate will be entertained showing salary, proper time period, dispatch Number with date, signature seal and stamp etc. It is mandatory to attach salary slip/ salary proof with application form.
8. No person, who has been dismissed from the Mission under any State or at National level or from the services of the Government of India or any State



Government or a local authority, a Corporation or Institute, shall be eligible for appointment to any post.

9. If an applicant does not fulfil the essential qualification or experience criteria or found to be fake then his/her application will be rejected & no written intimation will be given in this regard.
10. All posts are on contractual basis. The contract will be valid up to 31<sup>st</sup> March 2026 or as per DGHS /Higher Authority order and may be extended further if required.
11. Original documents in support of academic qualifications and work experience shall be required to be produced at the time of documents verification.
12. These posts are non-transferable and the selected candidates will remain posted at the place of posting but Controlling Authority has desired their services elsewhere then they provide their services their.
13. Performance will be reviewed after 3 months and continuation of service will be on the basis of performance & if performance is found unsatisfactory then contract may be terminated.
