**OFFICE ORDER**

Whereas, the names of the 328 candidates recommended for post of Clerk (Field Office) vide No. HSSC/Confid./CA-14/CET-Group -C/2024/654 dated 19.10.2024 against Advt. No. 04/2024, Category No. 380 by Haryana Staff Selection Commission, panchkula., And whereas, the HSSC Panchkula, while recommended the name of the selected candidate had made an observation as under –

“ The selected candidates have not been medically examined and no special enquiry into their antecedents has been made. The documents pertaining to their Essential Qualification, Age, Caste/Cateogry, College/University etc. as claimed by the candidates in the application form may be got verified from the issuing authorities. A Copy of the appointment letter issued to the candidates may also endorsed to the Commission. vide instructions No. 52/06/2018-2HR-III dated 11.10.2024, the State Govt. has decided that Provisional Appointment Letters may be issued to all the candidates recommended by HPSC/HSSC for a post of Group of A/B/C/D subject to relaxed provision and time limit as mentioned in instruction dated 11.10.2024. Further, it must also be specifically mentioned in the Provisional Appointment Letter that in case of unfitness in any of the conditions mentined in above said instructions, the service of newly appointed employee will be terminated immediately without any notice.”

Accordingly, the Provisional Appointment to the post of Clerk (Field Office) issued vide letter No. 2/39-2E1-2024/4036-4364 dated 20.10.2024 and the Documents / Biometric Verification Committees were constituted to verify the documents/biometric verification of selected candidates. All the candidates were called, by uploading the public notice on the health department website, for verification of their documents and biometric verification on dated 22.11.2024. Thereafter, another opportunity for verification of documents was given on dated 16.01.2025 to those candidates who remained absent on 22.11.2024 due to reasons best known to them. Thereafter, last opportunity for verificaton of their documents and biometric was given by the department on 27.02.2025. Even after the three opportunities, the 14 candidates as mentioned below failed to appear before document and biotmetric verification committees.
