Subject:- Mediation "For the Nation" Campaign (90 days' Mediation drive to settle pending cases in all the Taluka Courts, District Courts and High Court of India).

This is to inform you that the National Legal Services Authority (NLSA) in collaboration with Mediation and Conciliation Projects Committee (MCPC), Supreme Court has initiated a nationwide campaign titled 'Mediation For the Nation'. This 90 days intensive drive scheduled from July to September, 2025 aims to settle pending cases in all the Taluka Courts, District Courts and High Court's of India through mediation.

In pursuance to the above, the Mediation and Conciliation Committee of Punjab & Haryana High Court convened a meeting with the Chief Secretaries' of Punjab & Haryana, Home Secretary, UT, Chandigarh, Advocate Generals of Punjab, Haryana and Standing Counsel of UT, Chandigarh on 16.07.2025.

In the aforesaid meeting following decision were taken:-

- (i) Director, Mediation and Conciliation Center of Punjab & Haryana High Court shall provide a list of cases relating to Land Acquisition and Service Matters.
- (ii) The departments whose matters are pending in the High Court, as per list provided by the Director, Mediation and Conciliation Committee, Punjab & Haryana High Court, as also other suitable cases, which have the potential of settlement and can be referred to Mediation.
- (iii) Alongwith the cases as mentioned at (i) & (ii) above, the cases related to HSVP and HSIIDC (HUID Category) would also be explored by both the States through their respective departments for mediation referral.
- (iv) The concerned departments should study the Litigation Policies of the respective State Governments and identify the matters having potential of settlement.

- (v) The State Govt. of Punjab, Haryana and UT Administration initially provide a list of cases identified suitable 'For Mediation' to the Director, Mediation and Conciliation Centre by 21.07.2025 and the final list of identified cases shall be provided to the Director, Mediation and Conciliation Centre by 25.07.2025.

Keeping in view the above said decisions, it is requested to take following action immediately:-

- (i) The concerned departments should study the Litigation Policy of the State of Haryana (copy enclosed) and identify the matters having potential of settlement in consultation with Advocate General, Haryana. A list of cases provided by the High Court is enclosed herewith.
- (ii) The concerned departments shall directly provide a list of cases identified suitable 'For Mediation' to the Director, Mediation and Conciliation Centre by 21.07.2025 and the final list of identified cases to the Director, Mediation and Conciliation Centre by 25.07.2025, under intimation to this office as well as to the Administration of Justice Department.
