Subject: Instructions regarding issuance of Medico Legal/Post Mortem Reports in compliance to the direction of Hon'ble High Court, Chandigarh issued vide order dated 11.07.2025 in court case no. CRM-7958/2025 in/and CRM-M-10727/2025, Aniket Vs State of Haryana – Reg.

In ref. to the subject cited above.

With reference to the orders issued by Hon'ble Punjab & Haryana High Court in various court cases i.e. IOIN-CRM-M-19280 OF 2011- Rajpal @ Labh Singh & others versus State of Haryana & others, CRM-M No. 7956 of 2020 titled as Baldev Singh versus State of Punjab and CRM-M No. 37717 of 2020 titled as Sunil Kumar & another versus State of Haryana. Recently passed order dated 11.07.2025 by Hon'ble High Court, Chandigarh in court case no. CRM-7958/2025 in/and CRM-M-10727/2025, Aniket Vs State of Haryana. It was decided that a time frame w.r.t. issuance of MLR/ PMR, X-ray reporting, final opinion of Medico-Legal/Postmortem cases etc. shall be followed to expedite the process and to help out in imposing appropriate sections under the criminal laws. Accordingly; the instructions regarding time frame are as follows:

1. All the Medical Officers especially the new recruits shall be registered on the MedLEaPR portal.
2. In case of transfer/deputation/promotion, it is the duty of concerned doctor to inform the MedLEaPR Support Team through email (support-medleapr@nic.in) to update the same on the portal.
3. No Handwritten MLR/PMR to be issued.
4. Preparation and submission of MLR/PMR by doctors on the MedLEaPR Portal should be reported immediately but not later than 24 hours in any case.
5. Medical officer shall generate Rukka /police intimation through online MedLEaPR portal. In cases Rukka is required, without generating MLR/PMR e.g. brought dead, death during treatment, MLR prepared elsewhere etc. In these cases also Rukka without MLR/PMR shall be sent through online MedLEaPR portal.
6. In case of non-functionality of the portal; a computer typed report to be issued immediately and then to be uploaded on the portal at the earliest but not later than 24 hours in any case.
7. The report of the portal to be freezed at the earliest but not later than 7 days.

8. The X-ray(s), wherever required, shall be done within 24 hours of admission of the patient, where the facility is available. In case of referral to higher center for X-ray(s), the same shall be done at higher opinion shall be provided within 72 hours of receipt of reports of such samples.


9. In case the doctor who performed the medico-legal examination and prepared the medico-legal report is transferred out of state/country/died/non-traceable, then treating doctor/board of doctors shall give final opinion on bases of investigations/treatment records on receipt of request from investigating officer.

10. In criminal cases if the doctors receive any communication from the Investigating officer of criminal matters then every communication should be replied by the concerned doctor within a maximum period of three days on the receipt of such communication.

You are therefore directed to adhere & also disseminate the above mentioned instructions to all the doctors/Government Hospitals/Medical Colleges under your control/jurisdiction in strict compliance to Hon'ble High Court, Chandigarh order dated 11.07.2025. Please submit action taken report in this regard at the earliest.

Kindly treat it as most urgent.
