WALK-IN-DRIVE

Willing and Eligible Specialists are invited to attend Walk- in- drive on 12th November 2025 and subsequently on *every Wednesday of every month, (till the posts are filled)* for the recruitment of following contractual posts of Specialists in District Panchkula (FRU) under National Health Mission, Haryana. Posts are purely on contract basis for fixed period initially upto 31st March 2026 (extendable, subject to further administrative approval and performance). The candidates shall ensure that they fulfill all the eligibility criteria required for the post as on the closing date of advertisement.

Registration shall be done strictly between 10:00 AM to 11:00 AM in Civil Surgeon Office, A Block 5th Floor, District Civil Hospital, Sector-06, Panchkula on the day of drive, followed by Original Document Verification. Application form can be downloaded from NHM Haryana web site i.e. nhmharyana.gov.in. Candidates are also advised to visit the website of NHM Haryana i.e. nhmharyana.gov.in and Health Department, Haryana i.e. haryanahealth.gov.in regularly for any corrigendum/notice/updates etc., as no separate communication will be sent for this. Incomplete application forms shall be rejected. Candidates are also advised to read the important instructions carefully before applying for the post.

Important Instructions for candidates: -

1. The candidates should be below 64 years of age.
2. Walk-in Drive will be held on every Wednesday of every month (till the posts are filled). If, Wednesday of the month is a public holiday, then the recruitment will be held on the next working day.
3. Post of reserve category will be filled up as per Haryana Govt. Reservation policy.
4. NHM Selection criteria (Annexure-A) issued vide memo no. NHM/Admin/HRC-1/2025/4306-26 dated 06.05.2025 shall be followed for recruitment. It is clarified that no written test shall be conducted for the recruitment of above said posts under NHM at district level.
5. Private practice during and after duty time and on holiday is strictly prohibited.
6. A candidate must be in good mental and physical health and free from any physical defect, which is likely to interfere with the efficient performance of the duties required for the post. The appointment shall be subjected to their being declared medically fit as per medical fitness standards followed by the Health Department.
7. The candidates are required to produce all original qualification certificates, and other relevant documents etc. in support of their eligibility. Further, to submit the attested/self attested legible copies of following qualification certificates and other relevant documents along with the Application form on the date of Walk-in-Drive:-
 - I. Valid Document as a proof for Date of Birth (10th certificate/Birth certificate).
 - II. Degree Certificate of requisite qualification
 - III. PG Degree/Diploma Qualification Certificate as required
 - IV. Mark sheet of each year/Semester
 - V. Registered as Medical Practitioner with Medical Council of India or any other State Medical Council of Indian Union.
 - VI. Post qualification relevant work experience in same field (if any), strictly as per NHM Selection Criteria (Annexure-A). It is clarified that the period of experience rendered by a candidate on part time basis shall not be counted while calculating the valid experience.
 - VII. Two latest passport size colored photographs.
 - VIII. Candidate claiming reservation should submit the copy of latest reserve category certificate issued by the competent authority as per the latest Govt. instructions.
 - IX. Self attested/attested copies of any of the three documents mentioned below as residential proof.
 - a. Passport
 - b. Voter ID Card
 - c. Ration Card with Address
 - d. Caste and Domicile Certificate with address and the photo issued by State Govt.
 - e. Parivar Pehchan Patra
 - f. Electricity Bill (not older than last three months)
8. The candidates should:
 - (I) Mark page numbers on the top at right hand side corner of each page and mention the total number of pages in the Application Form and detail of documents attached.
 - (II) Sign all the pages of the Application Form, qualification certificates and documents etc.



9. Candidates applying for a post must ensure that they fulfill all the eligibility conditions as on the previous day of closing date. Ineligible candidates not need to apply.
10. The application shall be subjected to subsequent scrutiny and can be rejected at any point of time if found incomplete/ wrong/not fulfilling the eligibility criteria etc. No correspondence in this regard shall be entertained.
11. NHM Service byelaws are subjective to decision by Finance Department, Haryana/Higher authority.
12. Selected candidate shall not have any claim for regularization of his/her services based on the duties performed under this contract, as he/she has been engaged for project financed by Govt. of India having specific tenure.
13. (I) It is clarified that a person/candidate who has been terminated or discontinued from the services of NHM as per the provisions mentioned in NHM Service Bye Laws at clause no.21 (b) & (c), he/she will be treated as disqualified candidate for any fresh recruitment under NHM as per the provisions mentioned in NHM Service Bye Laws at Clause no.9 (2) "Disqualification": No person, who has been dismissed from the Mission under any State or at National level or from the service of the Government of India or any State Government or a local authority, a corporation or institute, shall be eligible for appointment to any post.
(II) No court case/Police enquiry/FIR etc. should be pending against the applicant and he/she should not be convicted by any court.
"Selected Candidates shall submit the declaration regarding the same on legal stamp paper duly notarized".
14. Any instructions issued by Health Department, Haryana/NHM Haryana from time to time will be followed.
15. No TA/DA shall be paid for recruitment process.
16. Number of posts can be increased or decreased.
17. Documents verification of candidates will be done by this office. If any candidate is found with false documents at the time of appointment or later stage, his/her appointment/recruitment will be cancelled/terminated immediately without serving any notice and suitable action shall be taken against him/her as per rules/laws.
18. The candidature shall be provisional and will be subjected to verification of eligibility conditions with reference to original documents. Screening and selection will be based on the details provided by the candidate. Hence, it is necessary that applicants should furnish accurate, full and correct information in the application form.

This office reserves the right to cancel the whole recruitment process at any time at any stage without assigning the reason to the candidates.

Subject: Regarding partial modification in Selection Criteria for recruitment of Staff by the District Health & Family Welfare Society, Haryana on Contractual basis under NHM at district level- Modified.

In partial modification in Table "A" of this office letter no NHM/Admin/HRC-1/2022-23/10885-905, dated 20.03.2023, on the subject cited above, it is informed that, following revised/modified Selection Criteria for the recruitment of staff on contractual basis under NHM at district level be adopted with immediate effect. The modification in the NHM Selection Criteria for district level recruitment has been done after the approval of Hon'ble Health Minister and W/Additional Chief Secretary (H) cum Chairman Executive Committee of State Health Society, Haryana.

Note: Any of the above three documents (Sr.No:1 to 6) be produced at the time of recruitment.

Instructions:

1. It is clarified that, the recruitment of contractual posts under NHM approved in RoP, should be done with wider publicity in various newspapers through Directorate of Public Relations.
2. It is clarified that, no written test should be conducted for the recruitment of posts under NHM at district level. Only selection criteria mentioned above in this letter should strictly be followed for all future recruitments under NHM Haryana. No over & above criteria should be followed for recruitments under NHM at district level.

Additional guidelines for selection criteria are as under:-

- The formula for calculating the marks for Essential Basic qualification (Sr. no 1 of Table-A) will be done by multiplying the percentage of marks obtained by the candidates with weightage and divided by 100.
- 02 marks will be given for each completed year of additional relevant post experience, with maximum of 10 marks for all Posts.
- The reservation policy of Haryana Government should strictly be followed.

Note:

1. As Deputy Commissioner is the Chairman of District Health & Family Welfare Society, there must be an observer/nominee of Deputy Commissioner for the entire recruitment process, irrespective of the number of vacancies.

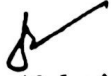

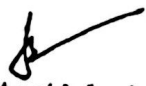
