Such candidates are directed to submit their representation, if any, against their proposed rejections alongwith deficient documentary evidence mentioned against each of the candidates; issued by the competent authority before the closing date of online application form i.e. 22.01.2026, through email morecruitment2024@gmail.com latest by 25.03.2026 by 11.59 P.M. ; failing which it will be presumed that they have nothing to say against their proposed rejection and their candidature will finally be rejected. The representation without any supporting document/s and received after the due date/time will not be considered by the department and no correspondence in this regards will be entertained by the department. The document/s received through any other mode than email, shall not be considered at all. Candidates are directed to submit their representation along with deficient document/s strictly as per the following instructions-

- a. The ESM/DESM category candidates are required to submit their valid eligibility certificate issued by the concerned Zila Sainik Board for the purpose of Haryana Govt. Jobs for F.Y. 2025-26.

- b. The Resident Certificate has not been attached by some of the candidates claiming the benefit of reservation, which is state specific.
- c. The name of candidates and their supporting documents do not match in some cases especially (Surname/Name of candidates/Father's name has been mentioned/not; in some cases) especially candidates claiming benefit of reservation; in various certificates including registration certificate.
- d. Schedule caste certificate has not been attached as per Haryana Govt. instruction dated 13.11.2024 by some candidates who have claimed reservation benefit.
- e. UDID certificate has not been attached by some of the candidates who have claimed the benefit of being PwBD.
- f. BC-A & BC-B certificates have not been attached by some candidates as per Govt. instructions no. 40/13/2024-1SW dated 16.07.2024.
- g. EWS certificate has been attached by some candidates w.r.t. the jobs/admissions in GOI whereas the EWS certificate for State Govt. jobs; as per Govt. letter no. 22/12/2019-1GS-III dated 25.02.2019, has not been attached.
