Regarding details of employees covered under EPF scheme as on

In reference to the above mentioned subject, it is to inform that details of EPF employees of PTCUL as on 15.04.2018 has been forwarded to LIC for actuarial valuation of annual contribution of gratuity vide letter no 54 dated 19.4.2018 in which salaries of employees from serial no. 01 to 443 are fixed according to 7th pay commission whereas fixation of salary of employees from serial no. 444 to 606 according to 6th Pay commission. The revised data after fixation of salary according to 7th pay commission of all the employees will again be forwarded to LIC for resubmission of demand note.

In response to the above referred letter, Manager, LIC vide letter no NIL dated 24.4.2018 (copy enclosed) has informed that if PTCUL provides revised employees data for mid term valuation before next Annual Renewal Date i.e. 15.4.2019 to assess the liability for funding, in such case the benefits on death of employee before normal retirement date shall be payable equal to the total of 15 days salary (last drawn salary) for each year of service upto the date of death and the sum assured under the term assurance on the ARD prior to the date of death.

Thus in light of the above, it is to inform you that service death cover of the employees at serial no 444 to 606 shall be calculated and paid as per the salary data provided to LIC on Annual Renewal Date i.e. 15.04.2018 in case the revised salary is not provided to LIC before 07.05.2018. However the gratuity amount shall be revised as per the data to be provided to LIC in mid term.

Hence you are requested to furnish the details of all the balance **163** employees covered under EPF scheme (salary fixed according to 7th pay commission) before 07.05.2018 for submitting the revised data to LIC for actuarial valuation of annual contribution for gratuity (FY 2017-18) so that they may not loose on the sum insured and accordingly the balance 163 employees (at Serial No 444 to 606) be informed that the benefit of service death cover will be payable to the employee/nominee according to the salary of 6th pay commission in case they do not submit their option form promptly.
