Tender fee (non-refundable) shall have to be paid by crossed demand draft in favour of **Executive Engineer, 400 KV O&M Division, PTCUL, Kashipur, Payable at Kashipur**.Nocash, cheque or postal orders shall not be accepted.

PART- A

1. The bidder can freely view and also download the e-tender documents from the website www.ptcul.org and also submit the bids on or before the dates as mentioned in column nos. 7 & 8 respectively of above table.
2. The tender fee, as mentioned above, shall be paid in shape of Demand Draft of any Scheduled/Nationalized Bank only and shall be in favour of **Executive Engineer, 400 KV O&M Division, PTCUL, Kashipur** payable at **Kashipur (U.S. Nagar)**. The tender fee shall be submitted in original with other tender documents, which must reach Office of **Executive Engineer, 400KV(O&M) Division, Ramnagar Road, Kashipur-244713 (U.S.Nagar) Uttarakhand** along with EMD and Schedule-C in separate envelope on or before the closing date & time of submission & opening of Part-I (Technical Bid). The scanned copy of tender fee shall also be submitted at the prescribed place. **Tender fee is non-refundable.**
3. The EMD can be submitted in the form of FDR/CDR of any Scheduled Bank /Nationalized Bank only and shall be pledged in favour of **Executive Engineer, 400KV O&M Division, PTCUL, Kashipur** payable at **Kashipur (U.S. Nagar)**. The EMD& other documents shall be submitted in original, which must reach Office of **Executive Engineer, 400KV(O&M) Division, Ramnagar Road, Kashipur-244713** along with Tender Fee and Schedule-C in separate envelope on or before the closing date & time of submission & opening of Part-I (Technical Bid).
4. The bidder has to quote their prices in '**price bid format**' as given on Web-tender website.
5. All the tender documents will be carried out only through Web-tendering mode and the bidder has to submit all his tender documents in the web-tendering website www.ptcul.org and in the meantime the bidders have to scan their Earnest Money Deposit (EMD), and all the pre-qualifying documents/Supporting Documents for uploading and also submit the hard copy of the same to the undersigned office within the last date and time of the submission of tender.
6. This office shall not be responsible if the tender fee, EMD and Schedule-C is delayed in transit or is not made available by the Postal Department/Courier at the prescribed address.
7. Web-tenders shall be received and opened on the date as mentioned above or any extension thereof. In case the above date is declared a holiday, the tenders will be received & opened on the next working day.
8. It is mandatory for the bidder to submit the hard copy of Schedule-C (Bid validity declaration) and 'Declaration' regarding correctness of the documents, in Rs.100 stamp, as per the format given in the PQR excel sheet of the tender documents and also upload the copy of the same on Web-tender website with the supporting document of technical bid proposal.
9. The bidders are requested to read all the instructions/conditions of the bid documents & NIT carefully and submit their bid accordingly. Be insured that all the required and supporting documents have to be uploaded on web-tender website.

PART B

PRE-QUALIFYING CRITERIA

(A) Technical Qualifying Requirement

1. The Bidder must be Experienced Contractors of having sufficient experience of vehicles or individual owner of vehicles and necessary proof to this effect be enclosed in part I st.
2. If contractor hired the vehicles he shall submit the hired agreement between owner and contract or affidavit for hiring of vehicles with period of 1 and ½ year from the date of opening of tender.

(B) Financial Qualifying Requirement

1. **Minimum Average Annual Turnover:** The minimum average annual turnover of the tenderer for the best three years (36 months) out of the last five years, audited accounts should not be less than Rs. 14.87 Lac.
2. **Access to Finances:** The bidder must demonstrate availability of access to finance for **Rs. 2.97 (Rs. Two Lakhs Ninety Seven Thousand Only)** at the time of bidding through a certificate (as per annexure-A) duly certified by a chartered accountant/auditor of the company which shall not be more than one month old on the date of submission of the bid.
3. For Financial Qualification Criteria, lead partner of JV Firms should meet minimum 50% of Financial Qualification Requirement (FQR) and collectively meet total Financial Qualification Requirement of the respective tender.
4. Experience of having successfully completed similar works during last seven years ending last day of month previous to the one in which applications are invited should be either of the following:

Three similar completed works costing not less than the amount equal to Rs. 3.96 Lakhs.
OR
Two similar completed works costing not less than the amount equal to Rs. 4.96 Lakhs.
OR
One similar completed works costing not less than the amount equal to Rs. 7.93 Lakhs.

In the above criteria, the "Similar Work" shall be "vehicle hiring.

- C. Registration in GST, EPF, is mandatory and the relevant certificates are to be submitted with the Technical Bid (Part-I).
- D. The balance sheet and other financial documents attested/certified by CAs to substantiate fulfillment of FQR should be with UDIN (Unique Document Identification Number) failing which the tender will be summarily rejected without any further reference
- E. The bidder shall not have any litigation pending with PTCUL. If any litigation is pending with PTCUL the bid shall not be consider.
- F. Bid validity :- 180days
- G. Completion Period:- 730 days
- H. Commercial documents for vehicles which shall be hired (RC, Insurance, Fitness, All India permit, Pollution certificate and other authentic documents)
- I. The Service provider should not have been black listed as on the last date of proposal.
- J. The vehicle to be provided by the bidder/contractor shall be in the name of the bidder/service provider/ & other as applicable.
- K. The other details, terms & conditions are given in tender documents.
