A. Qualifying Criteria

1.0 Technical Qualifying Requirement

QUALIFICATION OF THE BIDDER

Qualification of bidder will be based on meeting the minimum pass/fail criteria specified below regarding the Bidder's technical experience and financial position as demonstrated by the Bidder's responses in the corresponding Bid Schedules. Technical experience and financial resources of any proposed subcontractor shall not be taken into account in determining the Bidder's compliance with the qualifying criteria.

The Employer may assess the capacity and capability of the bidder, to successfully execute the scope of work covered under the package within stipulated completion period. This assessment shall inter-alia include (i) document verification; (ii) bidders work/manufacturing facilities visit: (iii) manufacturing capacity, details of works executed, works in hand, anticipated in future & the balance capacity available for present scope of works; (iv) details of plant and machinery,

manufacturing and testing facilities, manpower and financial resources; (v) details of quality systems in place; (vi) past experience and performance; (vii) customer feedback; (viii) banker's feedback etc.

1.1 Technical Experience

1.1.1 The Bidder must have experience of construction of 01 No. 110 kV or above voltage class bay along with Supply, Erection, Testing & Commissioning of associated equipment and Erection of 01 No. 110 kV or above voltage class Transformer of capacity 20 MVA or above. The above work should have been completed within last seven year and bay must be in satisfactory operation for at least one (1) year as on the originally scheduled date of Bid opening.

OR

The Bidder must have experience of construction of 02 No. 66 kV or above voltage class bays along with Supply, Erection, Testing & Commissioning of associated equipment and Erection of 02 No. 110 kV or above voltage class Transformer of capacity 10 MVA or above. The above work should have been completed within last seven year and bay must be in satisfactory operation for <u>at least one (1) year</u> as on the originally scheduled date of bid opening.

1.1.2 Transformer shall be sourced from the Manufacturer of Power Transformer who should have successfully carried out Dynamic Short Circuit Test on similar rating Transformer as on the originally scheduled date of bid opening and shall enclosed the relevant Test Report/ certificate along with bid in line with technical specification. A letter of confirmation from the manufacturer is to be submitted along with bid in case the bidder is not supplying transformer from its own manufacturing unit.

Note: In case of works executed under a contract that had been awarded on a Joint Venture, the experience of individual Joint Venture partner shall be considered limited to the scope of that partner under the said contract.

AIS means Air Insulated Substation.

Satisfactory operation means certificate issued by the Employer certifying the operation without any adverse remark.

In case bidder is a holding company, the technical experience referred to in clause 1.1.1 above shall be of that holding company only (i.e. excluding its subsidiary/group companies). In case bidder is a subsidiary of a holding company, the technical experience referred to in clause 1.1.1 above shall be of that subsidiary company only (i.e. excluding its holding company).

In order to have the clarity of term "similar works" of Financial Qualification Requirement (FQR) Similar Work for Bid Evaluation shall be: "Supply and Erection of equipments for Bays/Substation with Transformer/Reactor of voltage class 66 kV or above".

2.0 Financial Qualifying Requirement

- 1 <u>Minimum Average Annual Turnover:</u> The minimum average annual turnover of the tenderer for the best three years (36 months) out of the last five years should not be less than Rs. 28.61 Crores.
- 2 Access to Finances:— The Bidder must demonstrate availability of access to finance for Rs. 5.72 Crores at the time of bidding through a certificate (as per Annexure-A) duly certified by a Chartered Accountants/ Auditor of the company which shall be of a date within one month prior to the date of submission of the bid.

For Financial Qualification Criteria, Joint Venture Partners shall jointly / collectively meet 100% of Financial Qualification Requirement (FQR) of the respective tender.

Note: The balance sheet and all other financial documents attested/certified by CAs to substantiate fulfillment of FQR should be with UDIN failing which the tender will be summarily rejected without any further reference.

B. E.P.F. Registration certificate is mandatory to be submitted with the technical bid (part-I).
