

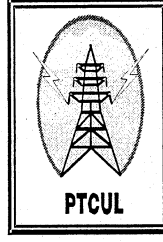

1. अभ्यर्थी उत्तर देने से पूर्व प्रश्न-पत्र में दिये गये निर्देशों को ध्यानपूर्वक पढ़कर उनका अनुपालन करना सुनिश्चित करेंगे।
2. अभ्यर्थी अपना नाम, पदनाम एवं अनुक्रमांक सही-सही भरेंगे, गलत प्रविष्टि/ अंकित करने के लिए अभ्यर्थी स्वयं पूर्णतः उत्तरदायी रहेगा।
