

3. The Transformers to be supplied should be type tested for it's design as per requirement of agreement.
4. Drawing and GTP to be approved by Engineering wing of PTCUL at the initial stage as per the terms & conditions of respective contract.
5. Company has to get the approval of MQP & FAT from QA/QC before commencement of their production.

6. This acceptance does not absolve the Company from contractual obligations & terms and conditions of the respective tender.
7. Validity of approval shall be considered based on timely supply & quality performance.
8. If any discrepancy/complaint observed in future, the Vendor Registration will be cancelled without any prior notice for which M/s Triple EEE Power Solutions Pvt. Ltd. will be fully responsible.
9. This Registration is valid for the period of 05 (FIVE) years from the date of issue of this letter.
10. Company has to apply for Re-registration at least two months before from the last date of expiry of this Registration.
