**Decision:** EC approved the minutes of 112<sup>th</sup> EC meeting of NILD Kolkata.


**113.02. Action Taken Report on the decisions taken in 112<sup>th</sup> meeting of EC, NILD.**

**Decision:** Action taken on the recommendations of 112<sup>th</sup> EC meeting of NILD Kolkata were noted.

**113.03: To consider the proposal for Optimizing Infrastructure at NIs / CRCs.**

**Decision:** EC discussed and approved the proposal for optimizing Infrastructure at NIs / CRCs with certain advices.

- i. All OPD charges i.e. Registration / Diagnostics / Treatment Fee to be waived off for UDID card holders, as well as for those who have disability certificate and have got enrolled on UDID portal, irrespective of % of disability, w.e.f. 1<sup>st</sup> January 2023 as proposed.



- ii. IPD charges i.e. Registration / Diagnostics / Diet / Treatment Fee to be waived off for UDID card holders, as well as for those who have disability certificate and have got enrolled on UDID portal, irrespective of % of disability, w.e.f. 1<sup>st</sup> January 2023 only for General Bed patients and not for patients staying in Cabins.
- iii. Full Course fee may be waived off for those students of various courses at our NIs and CRCs, who are UDID card holders, as well as for those who have disability certificate and have got enrolled on UDID portal, irrespective of % of disability. This should be done for 2022-23 batch students onwards (including those who are doing two year or more courses and are in their 2nd/ 3rd/ 4th year).
- iv. Data on such waived off charges to be submitted in next meeting of the Executive Council for further consideration.
- v. One month pilot project to be taken up to provide OPD Services on Saturdays only for limited hours i.e. 09.00 am to 01.00 pm with deploying staff through roaster duty from 1<sup>st</sup> January 2023.
- vi. Proposal for providing Emergency Services to the patients with practical approach may be submitted to the Ministry at the earliest.
- vii. Each NI and CRC should have a dedicated counter to help PwDs file UDID application.

**113.04: To consider the proposal for consolidation of pay of Senior Resident (PMR) and Senior Resident (Ortho).**

**Decision:** EC discussed and directed to refer the case to the Ministry for further examination and decision thereon.
