In supersession of this Department's earlier instructions issued on 26th December, 2016 regarding Selection Procedure for the Recruitment of Group 'B' (non-gazetted) and 'C' post(s) in the National Institutes (NIs) and Composite Regional Centres (CRCs) the undersigned is directed to state that all National Institutes/Composite Regional Centers will adopt the following procedure of recruitment with immediate effect:-

1	Written Test (Objective/Multiple Choice Questions)	80%
2	Desirable Qualification	10%
3	Desirable Experience	10%

(ii) In case where no Desirable Qualification or Experience is required as per respective RRs, 100% weightage will be given to Written Test and in case where either desirable qualification or experience is required as per RRs, 90% weightage will be given to Written Test.

2. The above instructions/guidelines contained under para 1 will not be applicable in cases where NIs/CRCs have already mentioned the earlier mode of selection, indicating sectional weightage of each & every parameter in advertisement, against which recruitment is under process.
