- (ii) In case where no Desirable Qualification or Experience is required as per respective RRs, 100% weightage will be given to Written Test and in case where either desirable qualification or experience is required as per RRs, 90% weightage will be given to Written Test.
- 2. The above instructions/guidelines contained under para 1 will not be applicable in cases where NIs/CRCs have already mentioned the earlier mode of selection, indicating sectional weightage of each & every parameter in advertisement, against which recruitment is under process.
