#### **TERMS AND CONDITIONS**

#### 1. **GENERAL**:

1.1. The bid document consists of particulars of tender, general terms and conditions, price schedule and other necessary documents.

#### 1.2. Location:

At Main Institute Building of National Institute for Locomotor Disabilities (Divyangjan), B. T. Road, Bon-Hooghly, Kolkata 700090.

1.3. The work shall be executed as per current CPWD General Specifications for work and as per relevant IS and as per directions of Engineer-in-Charge.

#### 2. COMMERCIAL CONDITIONS:

#### 2.1: Eligibility Criteria:

- 2.1.1. Percentage rate bids are invited from Eligible specialized firm/ agencies who are carrying out the 'similar type of works' # in PWD/CPWD or any other Government organization to undertake the work.
- 2.1.2. Self attested photo copy of satisfactory completion certificate of work as given below must

be submitted with Tender documents:

- (i) One similar work of value not less than **Rs. 0.56 Lakh** in any government/semi government or autonomous body during last three years ending January, 2022.Or,
- (ii) Two similar works, each of value not less than **Rs. 0.42 Lakh** in any government/semi government or autonomous body during last three years ending January, 2022. Or,
- (iii) Three similar works, each of value not less than **Rs. 0.28 lakh** amount in any government/semi government or autonomous body during last three years ending January, 2022.

The completion certificates must clearly indicate:

- a. The date of completion of work.
- b. Nature of work.
- c. Total value of work done.
- d. That the work has been completed satisfactory.

# 'Similar type of work' means E.I. work such as cable laying, cable termination work etc.

2.1.3. Self attested photo copy of GST registration certificate, company registration certificate/Trade License, PAN Card, Electrical Supervisory License, Electrical Contractor License, Partnership deed (in case of Partnership firm), photo copy of the cancelled cheque of the company's bank account and others must be submitted with the Tender documents as mentioned in the checklist as per Annexure II of this NIT.

#### 2.2. Type of Contract:

The work to be awarded by this NIT shall be treated as indivisible works contract.

#### 2.3. Issue, Submission and opening of Tenders:

- 2.3.1.
  - a. Tender documents can only be downloaded from the web site (<u>www.niohkol.nic.in</u>). The cost of tender paper amounting to Rs. 150.00 which shall have to be deposited by the tenderer directly to the bank account of National Institute for Locomotor Disabilities (Divyangjan), Kolkata through online mode, on or before the last date of issue of tender paper. The detail of the Bank Account of National Institute for Locomotor Disabilities (Divyangjan), Kolkata is mentioned in Annexure III. The copy of the transaction slip, duly signed by the tenderer, have to be submitted alongwith the bid document. The Duly filled in and signed tender paper will have to be submitted <u>in the specified tender box at Civil Engineering Department in the presence of Engineering in Charge, NILD, Kolkata</u> by the tenderers complete with the followings on or before **07.03.2022 at 2:00 pm**.
  - b. The earnest money amounting to **Rs. 1,743.00** which shall have to be deposited by the tenderer directly to the bank account of National Institute for Locomotor Disabilities (Divyangjan), Kolkata through online mode, on or before the last date of issue of tender paper.   - d. The tenderer shall have to clearly mention in bold letters the name of the work, NIT No, Date of NIT, Name of the Firm with full address & date of submission on the top of the sealed envelope (**sealed with GALA**) containing tender document.
  - e. Telegraphic/cabled/faxed/e-mail or any type of exposed tenders will be summarily rejected.
  - f. One no. of letter regarding self-declaration as per Annexure I in the company's original letter head must be submitted by the tenderer along with other tender documents.
- 2.3.2. The Tenderers are advised not to deviate from the technical specifications, items, commercial terms and conditions of NIT like terms of payment, guarantee, arbitration clause, escalation etc.
- 2.3.3. The bid only shall be opened on **07.03.2022 at 3:30 pm**.
- 2.3.4. Scrutiny/ evaluation of bid documents shall be done by the Tender Committee of NILD, Kolkata. In case if it is found that the bid of the Tenderer is not in line with NIT specifications, requirements and/or contains any deviations, the department reserves the right to reject the bid of such firms without making any reference to the Tenderer(s).
- 2.3.5. Any clarifications required by the department shall have to be furnished by the Tenderer within the time given by the department for the same. The Tenderer will have to depute his representative to discuss with the officer(s) of the department as and when so desired. In case, in the opinion of the department a Tenderer is taking undue long time in furnishing the desired clarifications, his bid will be rejected without making any reference.

- 2.3.6. In the bid document, submitted by the tenderer, shall be no condition whatsoever. In case any Tenderer mentions any condition including conditional rebates in their price part, Tender shall be rejected forthwith. A Tenderer will also not be allowed to withdraw or modify any condition after opening of the bids.
- 2.3.7. The department reserves the right to reject any of or all the bids and go for fresh Tenders as the case may be without assigning any reason.
- 2.3.8. The Director of National Institute for Locomotor Disabilities (Divyangjan), B.T.Road, Bon-Hooghly, Kolkata 700090 will communicate the LOWEST bidder by facsimile confirmed by letter transmitted by registered post that his bid has been accepted. This letter (hereinafter and in the condition of contract called the "Letter of Offer" shall prescribe the amount which National Institute for Locomotor Disabilities (Divyangjan), B.T.Road, Bon-Hooghly, Kolkata 700090, will pay to the contractor in consideration of the execution of the work as prescribed in the NIT.
- 2.3.9. The successful Tenderer shall submit an irrevocable **performance guarantee of 5%** of the Tendered amount in addition to other deposits mentioned elsewhere in the contract for his proper performance of the contract agreement within 07 days from the date of acceptance of tender. This Performance Guarantee shall have to be deposited by the tenderer directly to the bank account of National Institute for Locomotor Disabilities (Divyangjan), Kolkata through online/ offline mode. The original copy of the transaction slip, duly signed by the contractor, have to be submitted to this Institute within the above specified date. **The performance guarantee will be returned after satisfactory completion of work.**
- 2.3.10. The Director of National Institute for Locomotor Disabilities (Divyangjan), B.T.Road, Bon-Hooghly, Kolkata 700090, will award the work to the successful bidder whose bid is found to be responsive and who is eligible and qualified to perform the contract satisfactorily as per the terms and conditions incorporated in the bidding document. The work order will be issued after receiving of aforesaid performance guarantee.

### 2.4 Earnest money

### 2.4.1 Return/ Adjustment of EMD

- 2.4.1.1 EMD submitted by the unsuccessful bidders will be returned to the bank account of the respective bidders, as the detail mentioned by the bidders in Annexure IV, within 10 days after issuing of the work order for this work.
- 2.4.1.2 EMD submitted by the successful bidder will be adjusted with the security deposit, i.e. 10% of the bill amount, during final billing.

### 2.4.2 **Forfeiture of earnest money**

2.4.2.1 If any tenderer withdraws his tender before the expiry of the validity period, or before the issue of letter of acceptance, whichever is earlier, or makes any modification in the terms and conditions of the tender which are not acceptable to the department, then the Government shall, without prejudice to any other right or remedy, be at liberty to attract penal action of

forfeiture of EMD.

- 2.4.2.2 If contractor fails to furnish the prescribed performance guarantee within the period as indicated above, including the extended period, if any, it will attracts penal action of forfeiture of EMD.
- 2.4.2.3 In case of forfeiture of earnest money as prescribed in clause 2.4.2.1 & 2.4.2.2 above, the tenderer shall not be allowed to participate in the retendering process of the work.

#### 3. TERMS OF PAYMENT:

No advance payment will be made. The payment will be made on submission of the bill after completion of the job. Stipulations like levy of interest if payment is not made in specified time is not acceptable to the department.

#### 3.1. Security deposit:

Security deposit shall be deducted from each running bill and the final bill to the extent of 10% of the gross amount payable. The security deposit shall be released on expiry of guarantee period stipulated in the contract.

#### 4. COMPENSATION FOR DELAY:

The work is to be completed within the stipulated period. In case of delay a penalty @  $1\frac{1}{2}$  percent per month computed on per day basis subject to the maximum of 10% of Quotation amount will be recovered from final bill.

#### 5. Rates:

The rates quoted by the Tenderer shall be firm and inclusive of all taxes (including work contact taxes), duties and levies and all charges for packing, forwarding, insurance, freight and delivery, installation, testing, commissioning etc. at site.

Intending Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the nature of the building, the form and nature of the site, the means of access to the site and in general shall themselves obtain all necessary information as to risk, contingencies and other circumstances which may influence or affect their bid. A Tenderer shall be deemed to have full knowledge of the site whether he inspect it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidders shall be responsible for arranging and maintaining at his own cost, all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the tender documents and made himself aware of the scope and specifications of the work to be done and of conditions and other factors having a bearing on the execution of the work. No T&P shall be issued by the department and nothing extra shall be paid in this regard.

#### 6. COMPLETENESS OF TENDER:

All sundry equipment, fittings, termination lugs for electrical connections, dismantling of the existing electrical installations and all other items which are useful and necessary for installation of the work shall be deemed to have been included in the Tender irrespectively of the fact whether such items are specifically mentioned in the Tender document or not.

#### 7. STORAGE AND CUSTODY OF MATERIALS:

The agency has to make his own arrangement for storage of materials & equipments. No separate storage accommodation shall be provided by the department. Watch and ward of the stores and their safe custody shall be the responsibility of the contractor till the final taking over of the installation by the department.

#### 8. CARE OF THE BUILDING:

Care shall be taken by the contractor while carrying out the work to avoid damage to the building. He shall be responsible for repairing all damages and restoring the same to their original finish at his cost. He shall also remove at his cost all unwanted and waste materials arising out of the installation from the site of work.

#### 9. COMPLETION PERIOD:

Time of completion of the total work is **30(Thirty) days** from the date of issue of the work order as indicated in the Tender documents. The completion period is for the entire work of planning, supplying, mobilization of tools and manpower, installation, testing, dismantling the existing wiring, removing of unwanted and waste materials arising out of the installation from the Institute Campus etc. and handling over of the entire system to the satisfaction of the Engineer-in-Charge.

#### **10. PERFORMANCE GUARANTEE:**

10.1. The Tender shall guarantee among other things, the following:

- a. Quality, strength and performance of the materials used.
- b. Safe mechanical and electrical stress on all parts under all specified conditions of operation.
  - 10.2. Non performance by An agency:

If an agency does not start the work or does not perform the assigned work properly and/or in time, it shall be dropped from the list of approved/short listed agencies and their deposits including performance guarantee etc. shall be forfeited. Such agencies shall be debarred for tendering for a period of three years in this Institute. Such action shall be decided by Director, NILD, Kolkata. This shall form part of the contract as special conditions.

#### **11. GUARANTEE:**

All equipments shall be guaranteed for a period of **12 months** from the date of taking over the installation by the department against unsatisfactory performance. The equipments or components, or any part thereof, so found defective during guarantee period shall be forthwith repaired or replaced free of cost, to the satisfaction of the Engineer-in-Charge. In case if it is felt by the department that undue delay is being caused by the contractor in doing this, the same will be got done by the department at the risk and cost of the contactor. The decision of the Engineer-in-Charge in this regard shall be final.

### **12. VALIDITY:**

Tenders shall be valid for acceptance for a period of 90 days from the date of opening of bid.

#### **13. COMPLIANCE WITH REGULATIONS AND INDIAN STANDARDS:**

- 13.1 All works shall be carried out in accordance with relavant regulation, both statutory and those specified by the Indian Standards related to the works covered by these specifications.
- 13.2 Nothing in this specification shall be construed to relive the successful Tenderer of his responsibility for the installation work with all accessories in accordance with currently applicable statutory regulations and safety codes.
- 13.3 Successful Tenderer shall arrange for compliance with statutory provisions of safety regulations and departmental requirements of safety codes in respect of labour employed on the work by the Tenderer. In addition, the department will be at liberty to make arrangement for the safety requirements at the cost of Tenderer and recover the cost thereof from him.

#### **14 INDEMNITY:**

The successful Tenderer shall at all times indemnity the department consequent on this works contract. The successful Tenderer shall be liable in accordance with the Indian Law and Regulations for any accident occurring due to any cause and the department shall not be responsible for any accident or damage incurred or claims arising there from during the period of execution of work under the supervision of the successful Tenderer in so far as the latter is responsible. The successful Tenderer shall also provide all insurance including their party insurance as may be necessary to cover the risk. No extra payment would be made to the successful Tenderer due to the above.

#### **15 ERECTION TOOLS:**

No tools and tackles required for repairing, overhauling & installation purposes would be made available by the department. The successful Tenderer shall make his own arrangement for all these facilities.

#### **16 CO-OPERATION WITH OTHER AGENCIES:**

The successful Tenderer shall co-ordinate with other contractors and agencies engaged in the construction of building, if any, and exchange freely all technical information so as to make the execution of this works contract smooth. No remuneration should be claimed from the department for such technical co-operation. If any unreasonable hindrance is caused to other agencies and any completed portion of the work, has to be dismantled and re-done for want of co-operation and co-ordination by the successful Tenderer during the course of work to the original condition and specification of the dismantled portion of the work was not undertaken by the successful Tenderer himself.

#### **17 MOBILIZATION ADVANCE:**

No mobilization advance shall be paid for this work.

- 1. The work is to be executed such a manner that day to day activities of the Institute may not be hamper.
- 2. Work may be required to execute on emergency basis i.e. on Sunday/holidays/ beyond office hours depending up on the situation without any extra claim/charge.
- 3. Shifting of furniture, machinery etc. before and after execution of work shall be a part of tender work.
- 4. Shifted materials may be kept under the custody of contractor till those are handed over to the in Charge of respective unit for whom work executed.
- 5. Any damage occurs during shifting of Govt. article should be make good by the contractor.
- 6. The contractor shall have to make own arrangement of water and electricity for which nothing extra will be paid on that account subject to the condition that the water used shall be fit for the construction purpose.
- 7. Water and electricity, if possible, may be supplied to the contractor on request. Water and electricity charges @1% of gross amount of bill will be recover from the same.
