EXPRESSSION OF INTEREST (EOI)

National Institute for Locomotor Disabilities (Divyangjan), Kolkata invites offers from interested registered / authorized Common Bio-Medical Waste Treatment Facility (CBMWTF) for collection, transportation, treatment and disposal of Bio-Medical waste generated from the Institute as HCFs / HCUs for 02 years.

The interested CBMWTFs should submit their offer in the Prescribed Format of this EOI to the Purchase Section / Tender Box within 15. 02.2024 between 10 am and 4 pm addressed to "The Director, NILD, B.T. Road, Bon-Hooghly, Kolkata – 90" with the word **Expression of Interest for Collection, Transportation, Treatment and Disposal of Bio-Medical Waste** along with EOI No. B.Med/1151/EO/2005/NIOH/Pt-III/dated 25/01/2024 boldly super scribed on the top of the envelope.

SCOPE OF WORK

Collection, transportation, treatment and disposal of Bio-Medical waste for sanctioned 50 beds per day as per the guidelines for Management of Healthcare Waste as per Bio-Medical Waste Management rule 2016 and other terms and conditions as per Govt. rules and regulations amended time to time.

TERMS & CONDITIONS

1. The CBMWTFs agrees to provide the regular services of Collection, Transportation, Treatment and Disposal of Bio-medical wastes generated by NILD.
2. The Institute, Undertakes to segregate its bio-medical wastes properly in prescribed color coded Non Chlorinated HDPE bags and put sharp items in Puncture Proof Container (PPC) as specified in the Biomedical Waste (Management & Handling) Rules 2016 and as amended thereafter. For any amputated body parts, NILD will give the CBMWTFs a declaration duly signed by its authorized representative, stating the patient's name, age and reason for amputation as required under the Pollution Control Board's (PCB) regulations.
3. CBMWTFs shall send the monthly user charges invoice in duplicate to NILD on or before 10th of every succeeding month.
4. CBMWTFs will issue an acknowledgement of the collection of the bio-medical waste (System Generated Manifest) to NILD on the day of collection. This manifest will assist NILD to fulfill its compliance requirements under the provision of Bio-Medical Waste Management Rules (2016) and as amended. The manifest will be deemed as final and conclusive proof of collection in the event of billing and payment dispute.

5. CBMWTFs May supply to NILD upon request of the Institute for color-coded Non-Chlorinated plastic bags, puncture proof containers and other consumables materials at a rate mutually agreed. NILD will issue official purchase order to CBMWTFs for the supply of bags and any other items relating to the management and handling of bio-medical waste.
6. The CBMWTFs shall not delay in collection, even if not being collected should make alternate arrangement for the due collection and disposal of Bio-Medical waste. In the event of road block, strike, natural calamities and circumstances beyond its control CBMWTFs will not held responsible for collection of waste.
7. The CBMWTFs are required to quote the rate not beyond the revised rate for lifting, transportation and disposal of Bio-Medical wastes i.a.w. the West Bengal Pollution Control Board order vide memo no. 05-IS-74/2001(Pt. IX) dated 02.01.2023.
8. The CSMWTFs should have experience in doing similar nature of work in last 5 years.

TERMS OF PAYMENT

No advance payment will be made. The payment will be made as per Govt. rule, after satisfactory completion of the work. No extra payment will be entertained above the quoted rate.

RATES

The rates quoted by the **CBMWTFs** shall be firm and inclusive of all taxes i.e. GST etc. All the Rates should be in INR and should quote in the prescribed format only (*Annexure II*).

VALIDITY

Quotations shall be valid for acceptance for a period of 90 (ninety) days from the date of opening of bid.

AWARD OF WORK

Road, Bon-Hooghly, Kolkata 700090, will award the work to the successful bidder whose bid is found to be responsive and who is eligible and qualified to perform the contract satisfactorily as per the terms and conditions incorporated in the EOI document.
