# 1. **GENERAL**:

1.1. The bid document consists of particulars of tender, general terms and conditions, price schedule and other necessary documents.

# 1.2. Location:

1.3. The work shall be executed as per current CPWD General Specifications for work and as per relevant IS and as per directions of Engineer-in-Charge.

# 2. COMMERCIAL CONDITIONS:

# 2.1: Eligibility Criteria:

- 2.1.1. Item rate bids are invited from Eligible specialized firm/ agencies who are carrying out the similar type of works in PWD/CPWD or any other Government organization to undertake the work.
- 2.1.2. Self attested photo copy of satisfactory completion certificate of work as given below must be submitted along with technical bid documents:
  - (i) One similar work of value not less than **Rs. 1.52 Lakh** in any government/semi government or autonomous body during last seven years ending May, 2024.Or,

2.1.5. - 2.3.4. Scrutiny/ evaluation of technical bid documents shall be done by the Tender Committee of NILD, Kolkata. In case if it is found that the bid of the Tenderer is not in line with NIT specifications, requirements and/or contains any deviations, the department reserves the right to reject the bid of such firms without making any reference to the Tenderer(s).
- 2.3.5. The tender inviting authority reserves the right to ask for shortfall documents as per rule, if the bidder fails to submit the shortfall within the specific time given by the tender inviting authority. Any clarifications required by the department shall have also to be furnished by the Tenderer within the time given by the department for the same. The Tenderer will have to depute his representative to discuss with the officer(s) of the department as and when so desired. In case, in the opinion of the department a Tenderer is taking undue long time in furnishing the desired clarifications, his bid will be rejected without making any reference.
- 2.3.6. Conditional bids are not accepted. In case any Tenderer mentions any condition including conditional rebates in their price part, Tender shall be rejected forthwith. A Tenderer will also not be allowed to withdraw or modify any condition after opening of the bids.
- 2.3.7. The Financial bid of the eligible bidders only will be opened after security of the technical bid/s.

2.3.11. # 2.4 Earnest money

# 2.4.1 Return/ Adjustment of EMD

- 2.4.1.1 EMD submitted by the unsuccessful bidders will be returned to the bank account of the respective bidders, as the detail mentioned by the bidders in Annexure IV, within 10 days after issuing of the work order for this work.
- 2.4.1.2 EMD submitted by the successful bidder will be adjusted with the security deposit, i.e. 10% of the bill amount, during final billing.

# 2.4.2 **Forfeiture of earnest money**

- 2.4.2.1 If any tenderer withdraws his tender before the expiry of the validity period, or before the issue of letter of acceptance, whichever is earlier, or makes any modification in the terms and conditions of the tender which are not acceptable to the department, then the Government shall, without prejudice to any other right or remedy, be at liberty to attract penal action of forfeiture of EMD.
- 2.4.2.2 If contractor fails to furnish the prescribed performance guarantee within the period as indicated above, including the extended period, if any, it will attracts penal action of forfeiture of EMD.
- 2.4.2.3 In case of forfeiture of earnest money as prescribed in clause 2.4.1 & 2.4.2 above, the tenderer shall not be allowed to participate in the retendering process of the work.

# 3. TERMS OF PAYMENT:

No advance payment will be made. The payment will be made on submission of the final bill after completion of the work. Stipulations like levy of interest if payment is not made in specified time is not acceptable to the department.

# 4. COMPENSATION FOR DELAY:

The work is to be completed within the stipulated period. In case of delay a penalty @  $1\frac{1}{2}$  percent per month computed on per day basis subject to the maximum of 10% of Quotation amount will be recovered from final bill.

# 5. Rates:

The rates quoted by the Tenderer shall be firm and inclusive of all taxes (including work contact taxes), duties and levies and all charges for packing, forwarding, insurance, freight and delivery, installation, testing, commissioning etc. at site.

Intending Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before uploading their bids as to the nature of the building, the form and nature of the site, the means of access to the site and in general shall themselves obtain all necessary information as to risk, contingencies and other circumstances which may influence or affect their bid. A Tenderer shall be deemed to have full knowledge of the site whether he inspect it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidders shall be responsible for arranging and maintaining at his own cost, all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the tender documents and made himself aware of the scope and specifications of the work to be done and of conditions and other factors having a bearing on the execution of the work. No T&P shall be issued by the department and nothing extra shall be paid in this regard.

The defective fittings or parts of any items which are come out during the repairing replacement/ renewing work will be considered as the property of the service provider. Hence, the bidder should quote the rate according to this buy back policy.

# 6. COMPLETENESS OF TENDER:

All sundry equipment, shifting of items like furniture etc., safekeeping of the same, dismantling of the existing installations and all other items which are useful and necessary for the work shall be deemed to have been included in the Tender irrespectively of the fact whether such items are specifically mentioned in the Tender document or not.

# 7. STORAGE AND CUSTODY OF MATERIALS:

The agency has to make his own arrangement for storage of materials & equipment's. No separate storage accommodation shall be provided by the department. Watch and ward of the stores and their safe custody shall be the responsibility of the contractor till the final taking over of the installation by the department.

# 8. CARE OF THE BUILDING:

Care shall be taken by the contractor while carrying out the work to avoid damage to the building. He shall be responsible for repairing all damages and restoring the same to their original finish at his cost. # **10. PERFORMANCE GUARANTEE:**

- 10.1. The Tender shall guarantee among other things, the following:
  - a. Quality, strength and performance of the materials used.
  - b. Safe mechanical and electrical stress on all parts under all specified conditions of operation.
- 10.2. Non performance by An agency:

If an agency does not start the work or does not perform theassigned work properly and/or in time, it shall be dropped from the list of approved/short listed agencies and their deposits including performance guarantee etc. shall be forfeited. Such agencies shall be debarred for tendering for a period of three years in this Institute. Such action shall be decided by Director, NILD, Kolkata. This shall form part of the contract as special conditions.

# **11. WARRATY:**

All equipment/ accessories shall be guaranteed for a period of **06 months** from the date of completion of the work by the department against unsatisfactory performance. The equipment's or components, or any part thereof, so found defective during guarantee period shall be forthwith repaired or replaced free of cost, to the satisfaction of the Engineer-in-Charge. In case if it is felt by the department that undue delay is being caused by the contractor in doing this, the same will be got done by the department at the risk and cost of the contactor.
