# (A) Officers under Central / State Government / Universities / Public Sector Undertaking

(i) Holding Analogous posts in pay matrix as per 7<sup>th</sup> CPC or equivalent grade and minimum 5 years experience of research or rehabilitation or administration in the field of disability

OR

(ii) Holding posts in Level 12 of the Pay Matrix as per the 7<sup>th</sup> CPC or equivalent grade with 5 years service in the grade and minimum 5 years experience of research or rehabilitation or administration in the field of disability

OR

(iii) Holding posts in Level 11 in the Pay Matrix as per the 7<sup>th</sup> CPC or equivalent grade with 8 years service in the grade and minimum 5 years experience of research or rehabilitation or administration in the field of disability

And

Possessing the following qualifications:-

#### (B) Essential qualifications and requirements:-

Post Graduate Degree in Special Education or any other discipline from a recognized University/ Institution with 55% marks or equivalent grade.

<u>For Contract:</u> Essential and desirable qualifications as prescribed for deputation and as mentioned under (B) and (C) above would be required with 15 years experience of research or rehabilitation or administration in the field of disability.
