For Contract:- Essential and desirable qualifications as prescribed for deputation and as mentioned under (B) and (C) above would be required with 10 years experience of research or rehabilitation or administration in the field of disability.

General Conditions:-

- 1. Deputation will be governed as per rules of deputation as amended from time to time.
- 2. The appointment is initially for a period of 3 years and thereafter extendable on yearly basis, after review of performance, up to 5 years, as per rules of Government of India governing from time to time, He will, however, render himself liable to be discharged from the service if his work is not found satisfactory.
- Candidates must have to deposit (Non-refundable) Application Fees @ Rs.1000/- by General/OBC Category and @ Rs.500/- by SC/ST category through Demand Draft in favour of "Director, SVNIRTAR" payable at Cuttack. PwD candidates are exempted from payment of application fees.
- 4. Selected candidate will be initially posted at Composite Regional Centre (CRC) for Skill Development, Rehabilitation & Empowerment of Persons with Disabilities (CRCSRE), Guwahati, Assam. However, he /she is liable to be transferred to anywhere in India.
- 5. The post carries other allowances at par with Government of India Rules. Other benefits including LTC, Medical Reimbursement etc. will be admissible at par with Government of India Rules (for deputation only).
- 6. Applications received otherwise than through proper channel or received without requisite documents or received after the last date will not be entertained. It may be noted that advance copy of application received from an eligible candidate before last date of receipt of application may be considered provided duly forwarded application with required documents is received before the interview for selection is scheduled.
- 7. The Department / Organization while forwarding application may please be ensured that the officials who volunteer for the post shall not be allowed to withdraw their candidature later on in case of their selection.
- 8. Only shortlisted candidates will be called for interview. The Competent Authority, however, reserves the right to cancel or withdraw the vacancy without assigning any reason.
- 9. Mere fulfilling the minimum prescribed qualification and experience will not vest a right in a candidate for being called for Interview. The Institute reserves the right to call for Interview only those candidates who in its opinion are found to be suitable for the post.
- 10. Qualifications the candidates acquire should be strictly in accordance with the qualifications prescribed for the post. Any candidate seeking a claim of equivalence of the qualifications with the notified one will have to submit documentary evidence at the time of applying for the post. Further, where essential experience is required for the post only post-qualification experience shall be entertained.

- 11. Canvassing and /or bringing influence in any form will disqualify the candidature.
- 12. SC/ST/PwD Candidates (not in Govt. Service) called for Interview will be paid to and fro single second class train / bus fare by shortest route on production of train / bus tickets as per rules.
- 13. SVNIRTAR shall verify the antecedents or documents submitted by a candidate at the time of appointment or during the tenure of service. In case, it is detected that the documents submitted by the candidate are fake or the candidate has a clandestine antecedents/background and has suppressed the said information, his/her services shall be terminated.
- 14. Decision of the Institute in all matters regarding eligibility of the candidate, the stages at which such scrutiny of eligibility is to be undertaken, the documents to be produced for the purpose of the conduct of interview, selection and any other matter relating to recruitment will be final and binding on the candidate. Further, the Institute reserves right to stall cancel the recruitment partially / fully at any stage during the recruitment process at its discretion, which will be final and binding on the candidate.
- 15. The decision of the Institute in all matters will be final. No correspondence or personal enquiries shall be entertained by the Institute.
