She also interacted with NILD students and PwDs, also motivated and guided them for their career and respectful life in the community and society.

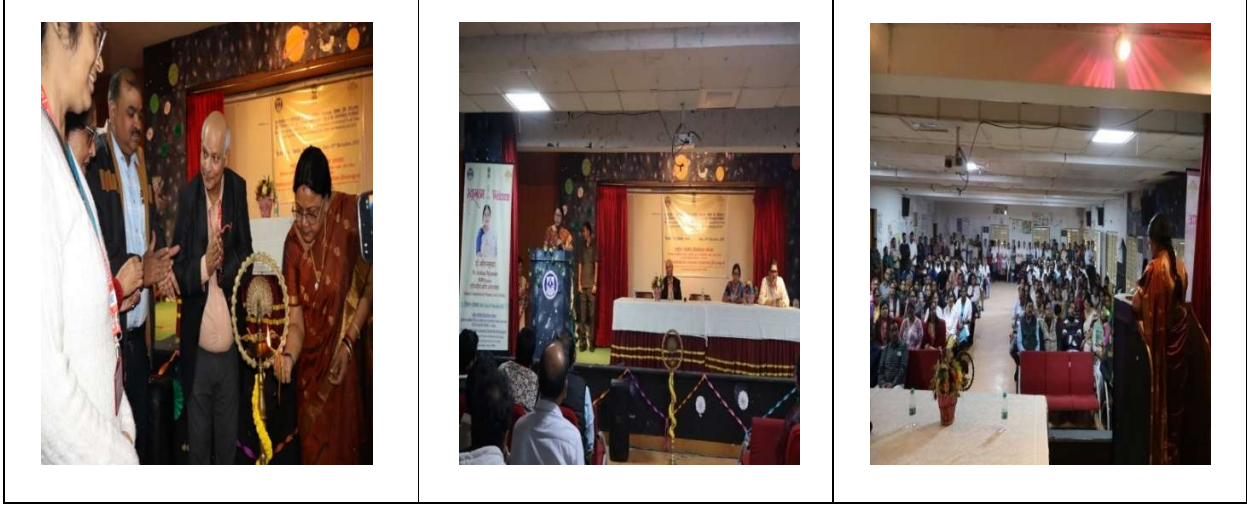
