TENDER NOTICE FOR APPOINTMENT OF AUCTIONEER

The Competent Authority & Administrator, Ministry of Finance, Department of Revenue, Government of India (Smugglers and Foreign Exchange Manipulators (Forfeiture of Property) Act, 1976 (SAFEMA) & Narcotics Drugs and Psychotropic Substances Act, 1985 (NDPSA), 10-B, Middleton Row, Park Street, 1st Floor, Income Tax Building, Kolkata-700071 invites quotations from registered Auctioneers to conduct Public Auction, E-Auction and Sealed Tender Auction for Immovable and Movable properties forfeited under the provisions of the SAFEMA and NDPSA within the jurisdiction of Competent Authority & Administrator, Kolkata.

2. Broad terms and conditions for the appointment of the Auctioneers are:

- (i) Auction may be conducted at any location within the territory of India.
- (ii) The Auctioneer shall be duly registered with GST.
- (iii) The Auctioneer must have experience of conducting, physical/public auctions and E-Auction of immovable properties for the last 5 years or more (at least 3 auctions for Government Agencies).
- (iv) The Auctioneer shall be responsible for conducting both Public Auction (Physical Auction) and E-Auction.
- (v) The website hired or possessed by the bidder should be security audited and fulfil all the mandatory guidelines issued by the Central Vigilance Commission (CVC)/GoI.
- (vi) The Auctioneer will be appointed for an initial period of one year, which may be extended, if found suitable.
- (vii) The Auctioneer shall be responsible for printing and distributing auction materials for wide publicity of the auction.
- (viii) The T.A./D.A. and other incidentals for conducting the Auction have to be borne by the Auctioneer.

3. Interested Auctioneers may submit their quotation through a sealed tender to this office latest by 18.08.2026 at 16:00 hrs. quoting rates separately for Public Auction (Physical Auction) and E-Auction. They may remain present at this office address on 19.08.2026 at 15:00 hrs., when the tender box is scheduled for opening.

4. The Competent Authority reserves the right to accept or reject any or all quotations without assigning any reason thereof.
