Subject: Submission of Pension Papers by retiring employees from State Government.


Sir,

I am directed to invite your attention towards Finance Department letter no. 2/32/2012-1Pension(FD), dated 03.12.2013 on the subject cited above and to say that the retired employees are facing difficulties at the time of release of first pension and other pensionary benefits as data of PPO can be entered in e-pension system only after unique code for payee (UCP) of the retired employees becomes available to the treasury officer. So treasury officers have to wait for the pensioner to visit the treasury and inform their UCP.

After careful consideration, it has been decided by the State Government that in future **UCP** generated in the e-salary system should also be indicated on top right corner of the pension papers which are forwarded by DDOs to the AG Haryana. **UCP** should also be indicated in all other correspondence with AG Office eg. for release of withheld gratuity/commutation etc. The Principal Accountant General Haryana will also insert the above **UCP** on all authorities relating to retirement benefits i.e. on GPO, CPO and PPO/FPPO of each retiree at the time of issue of sanction/authority.

You are requested to bring the above guidelines/instructions in the knowledge of all DDOs/employees for strict compliance.
