I am directed to invite your attention towards Government letter No. 22/10/2010-3GS-III dated 2.07.2010 which inter alia provides that in case no candidate is found suitable for appointment in Group 'C' & 'D' category, **even on re-advertisement**, the vacancies reserved for ESM of a particular category will be filled up from amongst the same category candidates.

The matter has been reconsidered by the Government and it has been decided to delete the word "**even on re-advertisement**" from the third paragraph of the letter dated 02.07.2010. Rest of the contents shall remain unchanged.
