Issue of Free Bus Pass to Disabled soldiers.

In continuation of this office memo no. 19/2/2006-2T(II) dated 17-04-2008 on the subject noted above.

- The Government of india has accepted the recommendations of CSC for the extention of Broad Banding of pension to the Armed Forced Officers who became invalid and discharged out of service prior to 01-01-1996 and are in receipt of disability war injury pension as on 01-07-2009. In these recommendations, the disability upto 20% or above has been Broad Banded and treated as 50% for pensionary purposes. Accordingly, the free travelling facility which was allowed to the 25% or above disabled Ex-service men shall now extended to the Ex-service men having disability of 20% or above.
- 3. However, this facility shall continue to be provided on the recommendation/identification issued by Haryana Rajya Sainik Board, Further, this facility shall be provided in the ordinary buses of Haryana Roadways within the jurisdiction of Haryana State only, including Delhi and Chandigarh.
